HIGHLIGHTS/"3 UPS":


1. Summer Patrols in full swing

DETAILS:

- With summer finally here, Operations have been ramping up to full throttle at the lakes we patrol along the Wasatch Front Bear Lake, Deer Creek, Jordanelle Reservoir, Utah Lake, and Willard Bay. We have 8 facilities patrolling these various lakes. Auxiliarists in the Operations Program have already done quite a few assists and SARs. New crew candidates and auxiliarists who will be requalifying at our Optrex in August are working on getting ready for their QE sessions.
- Division 7 enjoyed a visit from DSO-DV Tim Kahn who gave the Division Board a presentation on Diversity June 28. His presentation was excellent, and everyone at the meeting came away with a better understanding of the different aspects of Diversity in the Auxiliary. He gave a thorough overview of the NACO Three Star Award for Excellence in Diversity that will play a major role in setting 2019 goals for Division 7 Flotillas and Division. It is always very much appreciated when we have DSOs visit as it gives our members an opportunity to ask questions and get a better understanding of each of our programs. My heart-felt thanks to Tim for making the trip to Utah and for his timely presentation as we look forward to 2019. And we were sorry to learn that he will be retiring at the end of 2018.
- Paul Custance (FC, Flotilla 73) and Carl Henning (FC, Flotilla 76) and several others organized an outstanding training event and Division activity on June 22-24. Auxiliary facilities involved were *Z-Boat, Rover, Justice, and PWV 1* and *PWC 2*. Radio facility was provided by Rex Miner. A total of 21 Division 7 Auxiliarists attending the event for good times, friendship, and good fellowship.
 - Como Mike Williams attended the event and sent me the following report: "In observing the
 training and logistical support, I congratulate all involved for a successful, and professionally
 executed event. Once again it is reinforced that we gain confidence in our ability to respond
 by spending many hours on the water, facing scores of unique and complex situations.
 Competence, skill, training and repetition of basic tasks builds extreme confidence."
 - Como Williams also reported: "Willard Bay presents many unique challenges. In responding to a disabled PWC, ZBoat experienced a unique situation. The operator, who was mute and deaf. His young daughter (I presume) tried to interpret and explain what the situation was. In a very challenging situation, Ann and her crew responded with great understanding and professionalism. Eventually Roy and Sara Vandermolen provided assistance from their PWC to finish up the tow and trailering."

- Many involved in this event arrived Friday, June 22 to set up camp and stayed the entire
 weekend. Saturday and Sunday morning activities consisted or training, patrols, VEs, and
 working on qualifications. Everyone met back at the main campsite for lunch on Saturday,
 and Saturday afternoon resumed with more training, patrols, and VEs. Saturday evening after
 patrols everyone gathered together for a delicious potluck dinner and a lot of fellowship.
- Several Auxiliarists did VEs, several Auxiliarists got out of REYR status in both Operations and VEs, and many training hours and patrol hours were put in for preparation for the August OpTrex.
- I would like to add my congratulations and thanks to Flotilla 73 and Flotilla 76 for their hard work with this event. It has set a high bar for future Division events, of which I am sure this event will be a continuing event on Division 7's yearly calendar.



- Preparations continue for our August 18 Optrex at Jordanelle Reservoir. The following are working towards being at our Optrex: 1 new crew candidate, 4 boat crew candidates for requals, and 7 coxswains for requals.
