Highlights:

Details of Flotilla Reports:

- **FC for Flotilla 08-07 reported the following:**
 - Weekly fuel farm recirc and testing completed during May along with one Helo refuel assist...
 - Point Cabrillo and Point Arena:
 1. One major polishing of the lens was performed.
 2. One scheduled cleaning of the lamp was performed
- **Flotilla 08-08: Reported the following:**
 - **Activities**
 - They requested a letter from the Board of Supervisors designating the week of May 19-26 as "Safe Boating Week".
 - Betty Strack is conducting Safe Boating classes. In May she had 6 attendees and all passed.
 - He reported that Walmart no longer is issuing a grant for the purchase of life jackets. The Lioness Chapter has awarded them a grant of \$1,500. The Flotilla could not accept this money, so the Lioness Chapter purchased the life jackets from Walmart who gave them a 10% discount on this purchase. The Lioness's are non-profit organization and did not pay taxes.
 - The Flotilla will give away life jackets at the upcoming Lake County Fair.
 - Phil Mimino, a transferee from Tennessee has been very active with the Flotilla. He has 2 boats and had 2 coxswains. They patrolled Clear Lake on Memorial weekend and will be on the lake 4th of July.

- **PUBLIC AFFAIRS:**

Also basic info about how to join the auxiliary and the process to assist as FSO, as well as boat crew training, seamanship training, and boat safety classes.

 - Brochures and flyers are being developed and will be replacing current ones in stores and businesses
 - Webpage has been updated along with our Facebook page and fully approved by WOW standards and DIRAUX
