Training was for Special Forces parachuters who would be practicing water landing in the lake and be picked up by Special Forces vessels. The ranger at Deer Creek Reservoir asked for the Auxiliary's help to provide perimeter control at the north end of Deer Creek Reservoir to keep boaters out of the area during this training. 

- Utah Governor Gary Herbert has sent a letter to all boat owners in Utah asking for their help in the battle against quagga mussels. It specifically mentioned an unprecedented number of boats exiting Lake Powell have been found to have invasive mussels attached to the vessel and inside intake and water systems, even after only being in Lake Powell for a day or two. The letter encourages all boaters to be sure to have their boats professionally decontaminated when leaving Lake Powell. Utah inspection stations statewide have been experiencing an increasing number of boats during secondary boat inspections that are quagga-contaminated, which should be a high concern to all boaters not only because of the damage it can do to our boats, but also to our lakes, recreation, and public utilities that depend on our lakes for water in our dry desert climate. I hope the boaters of Utah take this warning to heart to protect Utah's waterways.
- Flotilla 07-03 organized and sponsored a campout activity on August 25-26, 2018 at Deer Creek
 Reservoir. Ten Auxiliary members attended and had a great time. They invited the Deer Creek
 rangers to dinner on Saturday night, at which the rangers thanked the Auxiliary members for all their
 hard work, support, and the example and education given to the boating public during the year. It
 was nice to hear from the rangers and to know our efforts are valuable and appreciated by the Utah
 Parks personnel we support.
- Labor Day weekend represents the winding down of Utah's boating season and signals the coming end to Auxiliary patrols on our lakes for 2018. A few Auxiliarists will be supporting some "afterseason" triathlons or events at a few of our lakes in September. For many of us in the Ops program in Utah, most of our summer weekends are spent at our lakes on patrol. Division 7 has supported Utah Parks and Rec rangers and personnel in an outstanding fashion during our boating season and assisted numerous boaters and paddle craft enthusiasts who find themselves needing help in one way or another. I would like to congratulate all Division 7 members in the Ops program for their hard work, time, and effort they have put in this summer. We have had some very unique experiences this summer, and I look forward to reporting our accomplishments and experiences in my final two reports to the board as my term as Division 7 DCDR draws to a close.
