The class was taught by Vivian Matuk (California State Parks Division of Boating & Waterways). The class consisted of 10 individuals, 6 AUX personal, 3 yacht club members and one prospective new member. The Flotilla kindly provided pizza and soft drinks to all those in attendance. Flotilla 49 (San Jose) will host another Dockwalker Training event on Wednesday 1st of May at the American Red Cross in San Jose.
- 2. Division 4 members will attend and support the San Francisco Marine Flare Collection Event being held on Sunday 14th of April (flyer attached). Members will have the opportunity to put their Dockwalker training to good use, promote safe boating and advertise Auxiliary activities. We also look forward to supporting further activities with the California State Parks Division of Boating & Waterways.
- 3. FC Onno Hommes of Flotilla 49 gave an excellent presentation on his experience as a watchstander at Air Station San Francisco during their March meeting. The presentation was very informative to all the Flotilla members and provided a great insight to Auxiliary activities for a prospective new member.
