District DSO-CM is looking into using the ACV "Aux Communications Vehicle" for emergencies such as the Camp or Sonoma Fires to support FEMA or OES (office of emergency services). see below

I would like to see the ACV utilized for incidents, but there are several things that need to happen prior to the ACV being put on orders for an assignment.

1. The radio installation needs to be completed. Radios were ordered and are/were in DIRAUX's office, but I haven't seen the list of the actual purchase. This shouldn't take long; antennas are in, power is ready, the radios need to be programmed.

2. Our only capabilities for the ACV's radios are VHF (136-174MHz) and MF/HF (2-30 MHz). The MF/HF radio will be programmed to work with federal, regional and state emergency management agencies for long range communications. We have no current plan to add UHF (380-512, 700, 800 or 900 MHz) radios.

3. Acquiring a "team" to support shift work may be problematic in finding enough operators along with a leader willing to be deployed for a possibly long duration.

4. While there is usually an incident base with all means of logistical support (meals, fuel, laundry services, supplies) available, lodging is another issue. An incident of the magnitude of the Camp Fire quickly occupies motel rooms in an area plus evacuees taking up the rest. Reimbursement via travel claim may work for shorter duration, but long-term deployment can place a hardship on members. An acceptable alternative could be a (class)room and locker room or similar for rest and personal hygiene needs.

I will absolutely support the ACV's deployment but the items above should at least be brought to the attention of those who may request our resources. I don't know if we need to have an MOA/MOU in place. Perhaps Bruce can shed some light on how it all works. I don't like to throw my friends under the bus, but the actual process seems to fall under IM.
