Since surface operations are on hold until further notice, how can Auxiliarists maintain their skills? One idea that was brought up at a recent Flotilla meeting involves vessel owners conducting on-the-water training as private citizens. This would not be done under orders and no Coast Guard Auxiliary placards or PPE would be displayed. Vessel tows would not be performed due to potential liability, but Coxswains and boat crew could conduct proficiency exercises such as man-overboard drills, navigation, piloting, and seamanship skills while underway. This is also an excellent opportunity for Auxiliarists wanting to qualify for Boat Crew to gain experience in line-handling, anchoring, participating as a lookout and maintaining a given course.
