- 1. Last Meeting of Year-October:** Our last meeting of the year was held on October 28<sup>th</sup> with planning shifting to the COW on January 9<sup>th</sup>, 2021 and awards calculations and production.
- 2. 2021 Budget Approval:** The Draft 2021 Division Budget was reviewed and approved with amendments at the October 28<sup>th</sup> meeting.
- 3. Elected Officer Training-Attendance Encouraged:** With the completion of our Flotilla Election cycle and following the October D11N Meeting, we have reached out to our newly elected Flotilla Leadership encouraging them to participate in the EOT program. They have been provided with the tentative class dates and times in December and encouraged to keep their eyes open for further notifications from District.
- 4. Chain of Leadership & DIRAUX Contact-Protocol Review:** With a few recent slip ups by members jumping the COL or contacting DIRAUX directly, Division included a thorough review of both subjects during our October meeting. We have asked our FC's to place these topics on their next Agenda's for review and discussion with their members.
- 5. Member Engagement:** The Division Wide survey results along with individual Flotilla results have been provided to our respective Flotillas. Division Leadership is encouraging our Flotilla Commanders to review the survey results with their members with an eye on developing member outreach programs at the Flotilla level. Flotilla 113-01-02 has included Guest speakers in their last two Flotilla meetings with good results.
