3-10 ordered 10 Boating America course books for instructors to review.

- · SO-CM Larry Stanton: D11 CCNET RTX training (on the air) took place over several days with D11 North members prior to test on 10-24. The HF/VHF support test was conducted on 10-24 from Sectors and Air Stations from Southern California to Humboldt Bay. The test was completed with an approximately 80 percent success. HF propagation created a loss of signal path to allow the last station (Air Station Sacramento) to complete their test. CDR. Graham impressed with the Auxiliary Communications capabilities. We will continue to build upon this experience. Many thanks to Carol Paz, Bob Torio, Jimmin Chang, Gil Gin, Kevin Sellstrom, Peter Todebush, Steven Busch and Desmond Thorsson for stepping up and taking on this significant commitment. - SO-AUC CG Station Rio Vista-Steve Harrison: Highlights:

- \* Station Rio Vista OIC BMC Bennet informed me the CG Reservists are back operational "for the most part", whatever that means. That CG Sector San Francisco is into Phase II for reopening. He has no information regarding AUX activities. I think annoying DIRAUX Bosn for u/w patrol orders might help move things along. Activity Details:
- \* CG Station Rio Vista conducted 16 SAR cases. The average October SARs over the last 14 years is 15 with 2008 seeing 32. The high number of SAR cases in 2007 thru 2011 is due to the drought limiting boating activity in the lakes forcing folks to come to the delta. The Station conducted 12 vessel boardings. The average October boardings for the last 08 years is 30 with 2014 seeing 68. Current Projects:
- \* Auxiliary Únit Coordinator (AUC) for CG Station Rio Vista for D11. I contact the Station by phone weekly for a SitRep as Auxiliary are not permitted on the Station. For the last eight months there has been nothing to coordinate. I expect this to continue for the rest of the year and well into 2021.
- \* Doug MacPherson began working with BMC Bennet to schedule a Boating Season Kickoff class at the Rio Vista CG Station this spring. This is the training session for Auxiliary members that was can-celed this past spring due to the COVID Virus.

Flotilla 35 has completed 24 of 32 PATONs Verifications (75%) under the Assignment to Duty approval by OIA/DIRAUX. (AUXDATA 1 & 2 shows 33 PATONs to date.

SO-OP John Hardin: Power Distance?

If you haven't heard of the term "Power Distance", join the "club". I recently encountered it while reading a report of the P/V NIPPON MARU striking a U.S. Navy fuel dock in Apra Harbor, Guam. Power Distance, as explained in this report, exists when there is a large gap in the level of authority or experience between crewmembers.

The effects of Power Distance are twofold. First, ignoring, downplaying or ridiculing the input of a junior crewmember deprives the senior crewmember of critical information the junior crew may have. Second, Power Distance can discourage or intimidate junior crew from even attempting to provide essential information necessary for the safe completion of the mission. Say "goodbye" to RM2 and to an enjoyable patrol.

In the case of the NIPPON MARU mishap, the master insisted on placing the thruster in reverse over numerous objections and physical interventions of the very much junior third officer. Making matters worse, the master may have been under the influence of alcohol. As a result, the 550 'vessel backed into the Navy fuel dock causing over a million dollars in damages and punching a hole in the stern of the NIPPON MARU. Fortunately, there were no injuries. On recreational vessels, a related form of Power Distance exists when a dominant spouse simply ignores critical input from the other spouse. Spousal Power Distance mishaps I have witnessed include attempting to get underway with mooring lines or power cords attached and delayed responses to re-peated spousal warnings of flooding and fires.
