# **DETAILS:**

- 1. Div. 5 2022 OPTREX The Division 5 OPTREX held on July 29-30 was a huge success producing 4 new crew members, 1 crew Reqaul and 1 Coxswain Requal. The Initial Crew candidates were the product of the joint training with Auxiliarist and Active Duty from Station Vallejo. The readiness of the candidates were said to be excellent by many in attendance. Joint training ensured that crew trainees will not only get valuable training that enable them to successfully demonstrate their skills and knowledge during Orals and Praticals but also imparts the seriousness of being a crew candidate. Bravo Zulu to the QEs Commodore Mike Maddox, Bill Stolz and DCOS Curtis Han, all involved in Joint Training and our new qualified crew members.
- 2. Port Chicago Memorial Last year's annual Port Chicago National Museum memorial service was attended by Auxiliarist Mike Smith (FL53). He noted that there was no Coast Guard representation even though five Coast Guard shipmates lost their lives in the tragedy. On the evening of July 17, 1944 two ships were being loaded with high explosives including incendiary bombs, depth charges, and ammunition. A subsequent explosion killed not only the 5 Coast Guards Men but also 320 Navy personnel and many others.

Mike Smith took it upon himself to ensure that the 2022 service will include Coast Guard representation. Mike along with his team coordinate a 29 RBS from Station Vallejo and Aux Facility SAR DOG to make a presence on the water and several Auxiliarists attended the service. Additionally, Dinia Paananen SO-DV noted that many of the killed where African American and ensured that their contribution was recognized through a series of Diversity articles written by Dinia. Bravo Zulu to Mike, Dinia and all that support this important even.
