This month I want to focus on the great work our committees completed this year. These committees work independently meeting regularly outside of the standard meeting.

## **DETAILS:**

- What do your members have to say? Under the leadership of Glenn Hunter and Tom Sarnicola, Div. 5 conducted a membership survey to get a better understanding of members' attitudes toward the Auxiliary, what are the roadblocks and how the Aux can better serve them. This survey is the catalyst to future surveys that will dive deeper into the Flotilla's performance and membership engagement. 36.6% of the members participated out of the 153 members in Division 5.
  - Key Highlights Include (Agree/Strongly Agree):
    - > 91% Their Flotilla offers activities that interest them.
    - > 89% Their Flotilla provides New Member Training/Mentoring.
    - > 78.5% They are engaged with their shipmates.

## Challenges from a summary of Verbatims:

- > AUXDATA II Improve AUXDATA II. Make it more user friendly.
- ▶ HEALTH ISSUES Health issues limit my involvement in the Flotilla.
- SOCIAL EVENTS/FELLOWSHIP Have more social and fellowship events.

LIMITED TIME TO PARTICIPATE – Work, or other non-health reasons limit my involvement in the Flotilla. In summary, members that completed the survey seem to also be the same members that are doing the majority of participation. Participation generates more engagement and satisfaction. The challenge is to re-engage those members that have fallen off the last few years but were otherwise previously active. Bravo Zulu to Glenn and Tom, all the FC's looking at ways to better engage their members by using the insights that were gathered and those members that took the time to complete the survey and providing many valuable comments. The complete survey is attached below.

2. What Awards? – A very legitimate concern of Division 5 members is, how is it that I work very hard for the Auxiliary yet my shipmate wins the award? For that matter, what awards are available and how is the award winner calculated? We established the Awards Committee to focus on answering these questions. The team consisting of Glenn Hunter, Lew Derfuss and Curtis Han set out their goals and went beyond my expectations. The end results is that all Division 5 Awards are clearly identified with purpose, how the award winner calculated and who is eligible. They also created an Awards addendum to the Standing Rules to ensure that every member and leader can understand the awards and apply them accurately. In addition, the Awards are clearly outlined

along with the National Awards on the Div. 5 Consolidated Calendar. Finally, the details of the awards will be posted on the Division website for easy consumption by members. Flotillas are encouraged to review the Awards with members and collectively decide if they want to focus on certain awards.

- 3. 2022 National Safe Boating Week Success NSBW is a big deal in Division 5. This is one of the first committees that are established at the beginning of the year. Traditionally the VCDR takes on the role of Committee Chair as this is an opportunity for the VCDR to develop and exercise leadership and teaming skills. Unfortunately this year Div. 5 did not have an active VCDR so Jimmy Matthies and Kit Galvin stepped up to co-chair the committee. They successfully helped Flotillas develop NSBW plans/activities, coordinated joint Flotilla event and helped with generating wonderful reports for each of the Flotillas.
- 4. 2022 Epic Change of Watch The Division 5 Change of Watch does its best to continue the tradition of a formal Change of Watch. The COW program is jammed packed with speakers and activities. We will continue the traditions such as Missing Shipmate Ceremony, Benediction, Featured Speakers, Change of Leadership Ceremony and Leadership Pledge. This year, the COW committee consisting of Lew Derfuss, Glenn Hunter, Randy McCormick and the FCs have secured the USCG TRACEN Petaluma to host the event. The USCG Culinary Services team will serve up Steak and Lobster and a custom decorated cake. The team has put many hours into the planning and preparations.
- 5. 2022 OPTREX 2022 Lew Derfuss and his entire team produced another highly successful OPTREX. A lot of planning and coordination goes into an OPTREX with the end result of training and qualification of operational members. Whether it was coordination with Station Vallejo with AUC Glenn Hunter, securing COMS during the event, food/drink provisions being made available, Facility Assignments, coordination with the Vallejo Marina staff and the coordination with the QE coordinator and staff, all takes many hours of time, documentation, training and execution by the dedicated team.
- 6. Can we do the monthly meeting better? At the January Div. 5 meeting, there was a challenge on how to make the meeting more efficient and effective. The committee of Division 5 leaders set out to improve the meeting and the result was much more focused meetings, reduction of one-on-one conversations (more collaborative), everyone being focused more purposeful and of course a much shorter meeting. Excellent work by all.
