## <u>Details</u>

- 1. Working with Partners (FL52): Erik Paananen (FC) and Dinia Paananen (VFC) gave a Sammy the Sea Otter/Marine Safety Presentation to 4 counselors and 25 students at St. Helena Parks and Recreation Summer Camp. This is the third year in a row that Flotilla 52 has done a presentation for St. Helena Parks and Recreation.
- 2. Memorial (F55): There was Celebration of life and a service for former Flotilla 55 member James Hermann Diekmann on June 8th at Bodega Bay Church. It was well attended by family members and friends of Jim. Frank Capurro, Jeff Tuttle and Jim Matthies attended the on behalf of Flotilla 55 Sonoma County. Division 5 is proud that all Flotillas purposely focused on Diversity and earned the award.

## **GOALS**

- 1. Create visibility for annual Div. 5 Performance Awards by publishing the available awards and publishing monthly results for each award. The result will be greater award awareness for all members and foster more competition among members.
- 2. Create opportunities for all Board and Staff members to participate in face-to-face meetings. Four All-Hands meetings are scheduled for a Saturday at Station Vallejo. - 2. Understanding and being able to properly articulate Policy changes in order to equip FCs to support and champion changes as their members challenge the change.
- 3. As membership drops at the Flotilla level, more pressure is put upon the Division to hold Division wide events. Funding of these events by the Division is becoming difficult. New avenues of revenue need to be developed to offset the additional funding pressure.
