  - Mailing lists for staff, board and members for Division 11 were created. Additions and deletions were verified with Aux Directory. Flotilla 3 and 4 also had members mailing lists created.
  - Moderators were implemented for Flotilla 3, 4 and Division 11 so that no spam or malware will get through to our membership.
  - Google calendar was added to the Division 11 site. This will be coordinated with District so that District wide events will also show on the calendar. Flotilla 3 will also have Google calendar added. Members can add events themselves by going to the calendar tab on the home page and adding their own events.
  - If you send an email to the mailing list it will look different than with our old mail client. You will receive an acknowledgement that you have sent an email. Once approved, you and everyone else on the mailing list will receive your email. Thanks to Bryce Leinan, Bruce Thee and Jim Snell for helping do the moderation. This should shorten the period of time before one of us gets to the moderation and approves it. By having moderation, members won't get spam and thus, avoid our Division and Flotillas from being listed as spammers.
  - We received a refund from Successful Hosting for months we did not have service on our contract. It is about \$28. I paid the first 6 months of the Host Winds contract which is about \$38. Once we pay our next invoice I will get with Dale to sort out the finances. The monthly amount will be split between the three entities that opted to participate. Flotilla 1 opted out.
  - We have unlimited domains, bandwidth, e mails and disc storage with our new hosting company. If flotillas or division members want to post videos, etc we can now do that without worrying about going over a cap.
