DSO-Updates and Div activities

Divisions 1, 3, 5, 6 report MEP activities in AWW, Spill Reports, MS Awareness and Dock walker training and Clean up of the CG Pier in Monterey.

Reminders AWW is a 70V Mission, Dock Walking is a 70N Mission, Ferry Vessel Audit is a 80G Mission and presenting a Marine Safety topic on missions or environmental protection is either 06B, or 70K if you are a MS staff officer any level.

Domestic Inspections and Exams UPV Exams

ADSO reports 2 UPV Exams were completed in Jan/Feb. The ADSO also assisted LT Walker in conducting a boarding officer class at STASF on Feb 14 regarding COI (Certificate of Inspection), UPV (Uninspected Passenger Vessels-6pack operator) and ORV's (Oceanic Research Vessel) Exams. A training at Station Golden Gate is scheduled for Mar 14.

It is important for boarding personnel to recognize the differences between Recreational boats, Commercial Fish, UPV and ORV's and how the Rules apply to each.

Ferry Vessel Audits

ADSO-MS/FVA reports No Ferry Vessel Audits completed in February. Take note that there will be a refresher training for Auditing at D Train this year. This class is required every two years for those auditors who have completed 2 Audit Missions each year. If you've missed your yearly audits, you should take the refresher each year.

Commercial Fishing

Crab Season and Dockside Exams will be coming up in May, along with an initial or refresher training.

Incident Management Division

Abandoned-Derelict Vessel and the new Shoreline Cleanup Assessment Technology (SCAT) will be presented at D Train on Saturday morning. Be sure to attend if you plan to take your boat out on patrol or you plan a Land Mobile Mission or an Air Patrol.
