Sixteen boaters were involved, all thrown into the water at night when two power boats collided head-on. Three were killed, one still missing. NONE of the 16 boaters were wearing PFD's. It is suggested that one boat was on wrong side of river with no lights. This is why our core task of informing our public on safety is so important.....Rick

California Boater Cards.



While this is not new news, by now all Coast Guard Auxiliarists should be aware of this new California, phased-in requirement for boaters with an engine to carry this card certifying they have completed an approved boating safety course. If you haven't already obtained your card, you should do so as soon as possible to set the example for the public.

This requirement--along with the wearing of PFDs--are two of the top items to be promoting on our RBSPV visits. A suggestion is to wear your California Boater Card in a plastic holder around your neck when you are making RBS visits to stimulate discussions. For those of you who will be doing shore duty in uniform for the upcoming Fleet Week, this would be an ideal time to wear your card, given the high profile visibility & interaction with the public. (This may have to be approved by your chain of command.)

Approved CGAux courses include: About Boating Safety (ABS) or Boating Skills & Seamanship (BS&S)
