



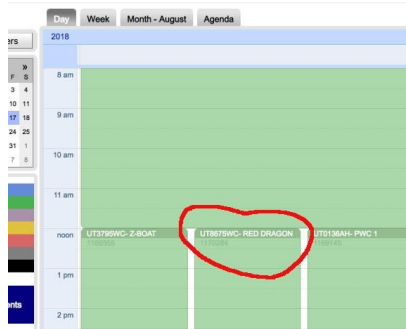

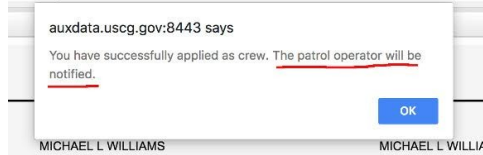

  - 6.1 Open up AOM and find the patrol that you would like to join.
  - 6.2 Click on the patrol and open the file. Here we have decided to ask to join the Red Dragon. on his patrol.



6.3 In the lower right corner look for the button "Apply As Crew" and click on it to request to join his patrol.

  - 9.1 ISPs are increasingly making sending emails from a mailing list more difficult because of stringent new requirements. Part of this is the need to use dedicated IP addresses for each domain. This has been difficult since we are on a shared hosting server.
    - 9.1.1 Reverse DNS lookups matching the domain name are increasingly required.
    - 9.1.2 DKIM, DMARC and SPF are also increasingly being required. I have had problems with these factors and am fixing these.
    - 9.1.3 It seems all the problems we have had with our web sites relates to emails and mailing lists. We have otherwise had no problems.
    - 9.1.4 We are attempting to change our Mailman email policies in an effort remedy bounce-backs
