#### Topic Details:

##### 1 More Divisions and Flotillas Join the District's Unlimited Photo Storage

- 1.1 A few months ago the District setup an Internet cloud with Google for photos. This space has unlimited storage for photos and videos alike. You can visit it on the District's site under Members Deck > Photo Gallery.
- 1.2 Tony Zocchi, District Photographer has been promoting the albums as he has been taking photos at events all over the District. Due to Tony's work more Divisions and Flotillas have asked for albums. Tony has posted close to 100 new photos to the albums. If you have not stopped by the page it's worth your time.
- 1.3 To this end, Division 10 working with the District CS team is taking this to the next level. They are working on building a number of albums covering such items as Fleet Week, COW, and more. Other Divisions have made inquires into following Division 10's example. Keep watching the site as Division 10 expands it's photo library taking advantage of the District's photo cloud.
- 1.4 The albums on the District's site can be linked from any Division or Flotilla and used as their own photo library. One of the nice things of this way of posting photos, is anyone can post photos without needing to pass it through a member of the CS team at any level. Once posted the photos show up instantly on the site. Members even have the ability to add comments to any of the photos.

##### 2 No More Unit Numbers on Webpages;

- 2.1 National has added a new politicize that they will no long identify Division and Flotillas by their unit numbers only. Therefor, the District CS team is changing our units identification to follow the directive from National. With one small change. To avoid confusion for the members we will keep the unit numbers on Flotilla too.

- 2.2 The following email was received:

For years, there has been much confusion over the way to designate flotilla and division numbers in publications. The Public Affairs Directorate, has changed the policy for how flotillas are to be designated in Auxiliary media at all levels.

As of 27 August 2018, a flotilla will be described by its name as it appears in AuxDirectory, without any unit numbers.

Examples:

Flotilla 43 in District 7 would be described as "Lake County Flotilla, Florida, participated in...".

Another example would be "Jim Smith, Flotilla Commander of the San Diego Flotilla, said...." The only time the state is required to be shown is when there could be confusion surrounding the flotilla's location.

In the case of divisions, the division number will still be used unless the division has a name assigned to it in AuxDirectory.

Examples:

"Division 5 in southeast Florida" or "The Oahu Division, Hawaii"

Publications already “at press” are grandfathered from this change. Future publications and media should reflect the new style.

I believe that this will also assist in helping market our flotillas. Currently the public does not understand our numbering system and by seeing the Flotilla name, this will give the public a starting point, if they wish to contact the flotilla.

The applicable PA and PB manuals will be updated to reflect this change.

  - 11.1 Uptime on our Host Winds server for our sites continues to be excellent.
  - 11.2 E-mails are improving. We no longer are being blocked by most ISPs. This is because (I believe based upon DMARC reports), we now pass Reverse DNS lookup, and our SPF. We still fail on DKIM (digital key) but ISPs only require passing one of either DKIM or SPF for that e mail to go through. I am working on the DKIM. Our hosting company tells me that if we update our DMARC to “quarantine” instead of “none” that we will pass muster on DKIM. The search continues. I intend to change our DMARC policy to quarantine and only for a small percentage at first.
  - 11.3 We moderate all of our mailing lists. However, sometimes there have been delays between time of submission of an email to the mailing list and approval of the e mail by a moderator. For this reason, we are not going to require moderation of e mails originating from either Flotilla Commanders, Vice Commanders or similar positions at the Division level.
