# 1. <u>ONE-HALF OF OUR VERIFYING PRIVATE AIDS SEASON IS OVER!</u> WE ONLY HAVE ONLY AUGUST AND SEPTEMBER TO COMPLETE OUR 2017 SEASON!

Each year, we have only until September 30<sup>th</sup> to perform our Coast Guard assigned field work and July is now over. By the end of July we completed **52%** of meeting our 2017 Annual assignments. Our annual challenge is 100%. How is your Division doing so far? Well, that's what this report/bulletin is all about.

Each year the Auxiliary commits to verifying 100% of the total assigned private aids in Eleventh District. While this is called an objective, in actuality, it is much more than that. Mainly because, if we don't complete this assignments, the D11 (dpw) are held responsible to complete them for us. So far, we have not failed the Coast Guard.

It is important to understand that Navigation Systems provides a multi-faceted program each year that breaks down into three main categories.

**1.** <u>Annual Bridge Survey Plan</u>. Bridges may be surveyed all year with focus on the spring months. 2017 is 100% Completed.

2. <u>Annual Private Aid Verifications Plan</u>. This program has a basic five month window for completion 100%. To date we have verified **52%** in 2017.

**3.** The "<u>Unauthorized Aid</u>" Program Plan. It is important to identify these aids and report them to the Coast Guard. Many of the unauthorized private aids have been identified or converted to a permitted PATONs. To date we have reported 17 non-permitted private aids in 2017.

When you review the critical part of the Navigation Systems Programs, Bridge surveys and PATON verifications is the most important parts due to their impact on D11 (dpw). With 50% of the operational year having passed, as always, there is good news and bad news. The good

news is the AVs have reported 100% of the bridges and 52.0% of the aids scheduled for 2017 verification. This is the good news.

And now for the bad news, one divisions has completed less than 25% of their assigned PATONs to date. Item number 3 on Page 4 shows a summary of the reported activity so far in 2017. Check out how your Division is responding to their 2017 assignments.

Each Division's progress is being tracked and reported to the District Board each month. Keep sending your reports or making your reports in a timely manner.

Check Item number 4 on page 5 for what AUXDATA has recorded for your Navigation Systems activity.

2. PLEASE JOIN ME AT THE **50TH** SEMI-ANNUAL PAST COMMANDERS ASSOCIATION TRAINING FAIR: I will be conducting Chart Updating ICS the and Auxiliary Aids to Navigation (ATON) Verifier PQS Training Course at the Past Commanders Training Fair on September 9 & 10, 2017. (1) Chart Updating CSI & NOAA's Nautical Discrepancy Report System: Again any Auxiliary member can participate in & do chart updating & coast pilot updating. This class will be held on Saturday, September 9, 2016. This course is for any Auxiliary Member who would like to learn all about Chart, & Coast Pilot Updating. How to submit your chart updated or Coast Pilot reports through the NOAA Office of Coast Survey - NOAA's Nautical Discrepancy Report System to assist the NOAA-National Ocean Service, NOAA Coast Survey and the U.S. Coast Guard in keeping our charts and waterways information correct. The focus for the Auxiliary Chart Updating program is on prevention, accuracy, credibility, and professionalism, and is directed toward raising your competence in the eyes of NOAA-NOS. There are specific guidelines for taking fixes and depths that require pre-underway validation of all equipment that is used to perform measurements, and for reporting quality control evidence for each on-scene observation and instrument reading. Also required are explanations of the technique(s) used to acquire any reported data. Auxiliary observers are directed to define each chart update task, list their on-scene observations, develop a conclusion from the collected evidence and make a final recommendation to NOS. A fresh scientific approach is encouraged. Evidence can take the form of a fix taken with a GPS set using WAAS, depths corrected to the charted vertical datum, physical measurements, photographs, drawings, marked up chart, Google Earth data and other printouts from the Internet can also supply great supporting data. Any official document that supports your contention is great supporting evidence. In effect, you are pleading your case for acceptance of your premise as a chart update or coast pilot update to NOAA-NOS. This class we also take you step by step on how to submit a report to NOS through the online Office of Coast Survey -NOAA's Nautical Discrepancy Report System.

Again any Auxiliary member can participate chart updating. Any Auxiliary Member who would like to update or improve their charting skills can also sign up. You can also find out about downloading excellent Chart Updating information, guides, training power points, all the new excel field reporting forms and worksheets and the WebEx Training Topics Schedule from the best two District Navigation Systems web sites in the auxiliary.

Any pass or present District Aid Verifiers who would like to update to the AV-PQS qualification or update their skills are also welcome.

The training Prerequisites to completing the course:


- 1) A BQ or AX member,
- 2) A current or past Aid Verifier and any Auxiliary Member,
- 3) Completion of the 4 or 8 hour TCT,
- 4) Completing ICS 100 and ICS 700,

5) You are required to have a copy of the <u>Auxiliary Aids to Navigation (ATON) Verifier</u> <u>PQS sign off booklet</u>,
