1A.

As of this report writing the Coast Guard does not have a budget. Please do not submit patrol orders until the budget has passed and an official message comes down from district. OIA's have been directed not to approve any orders at this time.

1B.

This is a re-print of the message that Mr. Leavell sent out earlier this month.

As many of you already know, the Commandant has approved the new Risk Management program. This program has been in transition for nearly a year now and is due to be complete in March 2019. However, there have been significant hurdles for the Auxiliary to transition to this new program. Currently BSX is still working to address these issues and provide specific guidance for the Auxiliary to transition. In an attempt to get ahead of the guidance and ease the transition, I recommend that all members involved in operations complete the online Risk Management Course found on the AUXLMS. The course, Introduction to Risk Management (course # 100202), is NOT required (at this time) but recommended. When complete, AUXLMS will automatically transfer completion to AUXDATA. We recommend you keep any confirmation you receive regarding completion of the course. You do NOT need to send any information to our office. We receive notification from the National Testing Center regarding successful completion which is filed in the member's permanent record.

Thank you to the 177 members of District 11nr that have completed the GAR 2.0, 100202 course on line. I hope some of you will take advantage of the 1 hour class being held at PCA.
