- 1a. We are in midst of a complete re-boot of the Risk Management system. The old Green, Amber, Red (GAR) is being fazed out and replaced with the new GAR 2.0. - 1b. <u>All operation personnel</u> are affected by this policy and there are deadlines to be concerned with to maintain the ability to request patrol orders or even crew on a facility. Even if you took the 5 year TCT training last year you will still need to take this new training.

The online portion, Introduction to Risk Management (course # 100202), needs to be completed no later than 30APR2019 and before you can take the required refresher workshop.

- 1c. Thank you to the 208 members of District 11nr that have completed the Introduction to Risk Management # 100202, on-line course.
- 2. The annual OPS WKS for District 11nr operations personnel is mandatory this year and must be completed by 30JUN2019 to stay out of REWRK.
