### Follow up to meeting with Sector Prevention, Ferry Boat Exams

### **Abandoned Derelict Vessel Program**

Three Aux personnel and Sector Response attended the quarterly stake holder meeting for the Abandoned Derelict Vessel on February 20. Cal State Land Commission, OSPR Office of Spill Prevention and Response (CA Fish and Wildlife), plus marina operators, County Sheriff and marine salvage companies attend this meeting that covers the identification and clean up efforts of abandoned boats in the Delta. One change is the program will be expanding from the Delta to a state wide program. Aux Air and our surface team will be planning on visiting D11S to set up training for this mission.
