### **AUX ICS-300**

The Q Directorate is engaged in developing a FEMA - NIMS compliant Auxiliary taught ICS-300 course. The CG ICS-300 may be delivered on-line via CG-LMS. This is under consideration at CG Headquarters (CPE & TRACEN).

Post conference call CG Headquarters offered the following guidance:

*A FEMA – NIMS compliant ICS-300 / 400 will suffice in lieu of the USCG ICS-300 or 400 course. Members who have taken an alternate course and want to submit it for further certification, must provide their completion certificates of meeting any prerequisites as determined with the specific PQS. The best person to facilitate this process is the local Area, District, or Sector ICS Coordinator.*

Discussion from DSO-IM D9 that CPE has waived the CG 300 requirement for CG ICS qualifications: Fritz Wasco, DSO-IM: During the ICS Coordinators conference call this April, CG-CPE announced that attending a FEMA 300 was fine for certifications.

I've noted emails for 2 of our regular hosts for the conference call below.

Obviously, they feel that the CG-501377 (ICS-300) course is superior, and should be considered first, but realistically getting certified shouldn't be held up by a course many Coasties can't seem to get due to many reasons. . . Travel costs being one that impacts reserves and auxiliary alike. As well as being low on the priority list

Now with that being said, the school chief LCDR David Vihonski as well as others indicate CG-300 is strongly considered to be going "online" probably the LMS platform - no set date yet.

### **AUX Incident Management Coordination Cell - IMACC status**

*"IMACC" Incident Management Coordination Cell vice "IMAT" - ONE concept for the Auxiliary same terminology Auxiliary-wide.*

AUX personnel should obtain ICS specific qualifications for augmentation within the respective Sector Incident Management Team / Incident Command Post when activated. This means prior collaboration with the Sector Contingency Planning & Force Readiness (Soon to be renamed Emergency Preparedness Department) within your Sector.

**[NOTE from Bruce: this effectively puts my IMT goal on hold pending the new system. National has requested we don't start efforts outside of the Q guidance.]**
