Commercial Fishing Vessel Safety Exams, (Operation Salmon Safe)

The recreational salmon season opens on April 13, and the commercial salmon season opens South of San Francisco on May 1. In anticipation of a big salmon season, CG D11N will be having Operation Salmon Safe at the 11 major fishing ports in No Cal on April 23-25. During the three day period, 18 examiners performed over 47 commercial fishing vessel exams with 15 post operation or follow up exams. For the month of April, over 75 commercial fishing vessels were examined. Including a few charter boats or UPV.
