Ferry Boat Exam Status

On May 18, Sue Fry, Michael Mitchell, Steve Johnson and I meet with Sector Prevention, Port and State LCDR Strom to go over the status of the Ferry Boat Outreach program. Sector is evaluating the program and will start having qualified ferry boat examiners conduct their outreach exams under a limited basis. Aux coordinator Michael Mitchell will assign ferry boats and routes to examiners, who will send in their reports both to Steve and Sector SF. Sector will then also review their dockside exams and look for any trends to see the impact on the ferry boat examinations. This process will start very soon.

UPV Examinations

There have been 4 Auxiliary members in Divisions 8 and 11 that have stepped up to the plate for learning the UPV examination process. ADSO Michael Mitchell is setting up a time and location for this training to occur.

Abandoned Vessel Surveys

Recently, the ADV program was expanded from the Delta to all of California. With the expansion, Jim Losi and Quindy Sammler have been conducting 12 ADV surveys in the Oakland Estuary. We plan on taking this program to D11 South and train their Aux Aur and Surface personnel to perform this mission.
