AuxAir continues to provide between four and six missions each week in support of the Coast Guard, the Auxiliary, and our allied agencies. We are assisting NOAA by monitoring and taking photos of the CEMEX operation near Moss Landing and both the Mud Creek Slide and Paul's Slide in the Big Sur area.

Our training of new members continues to go well. We have three auxiliarists in flight training and one of these will be a new pilot for the auxiliary. We have several others in the early stages of training and working on their prerequisites.

Our Fall Aviation Safety Workshop and swim test are scheduled for Saturday, 09 November 2019. These will be held on CGI with the Workshop starting at 0900 and the swim test will follow the workshop at the pool. As always, the swim test will include those auxiliarists who need this for their boat qualifications.
