1. National Prevention Department - Navigation Systems Division Updates.

- 1. Preparations for 2020 **AUX 06 C School Schedule** include Yorktown, VA and Huston, TX. There are only 15 students per school so early registration is suggested.
 - a. AUX 06 C School Schedule, is 12-14 June 2020-Training Center Yorktown Coast Guard Base Yorktown, VA. AUX 06 C School Schedule is TBD, Huston, TX is still being worked on.
 - b. Be sure to use the new 7039 (10-19) Short Term Training Request (STTR) sheet to request "C" Schools. Changes have now been put in place to remove the "first come, first serve policy".

If you are an AUX MBR not in an elected position and would like to attend a "C" School, you will now need the endorsement of the respective DSO in addition to your Flotilla Commander. For example, AUX-06 is the NS Course. AUX James B. Duncan is the DSO-NS. Therefore, you will need his endorsement in addition to your Flotilla Commanders.

Flotilla Commanders, Division Commanders, and District Captains you will need the endorsement of the person next in your chain of leadership. Which goes as follows: FC needs DCDR & DSO-NS, DCDR needs DCAPT & DSO-NS, DCAPT needs DCOS or DCO & DSO-NS

- 2. AUXDATA does not currently have "Currency Maintenance Met". DSO's manually track AV's activity and determine if AV's should be in REYR. a. Currency Maint Requirements memo has not been approved to date.
 b. Fields created with in AUXDATA to record AV met meets requirements.
 c. Training IS members to enter activities.
- 3. COMMANDANT INSTRUCTION 16500.16A 7/7/95 is so far outdate should it be cancelled or updated? YES. It has been forwarded to CG-NAV for review to update.
- **4.** NOAA has made comment about discontinuing some Raster Navigational Charts (RNC) Charts and moving to only Electronic Navigational Charts (ENC) charts. New chart plotters use the LNC format. If you are not using LNC Charts, this would be a good time to learn all about LNC charts by going to this **NOAA-Office of Coast Survey** web site https://www.nauticalcharts.noaa.gov/

Again, the FSO-IS, SO-IS & DSO-IS is the only members that can enter your Navigation Systems activity into AUXDATA.

NOTE: All Navigation Systems activity awards for this year and AV certifications for next year is taken from AUXDATA information. Remember the old saying "If it's not in AUXDATA it didn't happen." That is why you should always check the table above each month. So, this way you can see that if you have not reported your NS activity (7030) to your FSO-IS or they have not entered your NS activity incorrectly you have time for them to correct your information into AUXDATA. The FSO-IS or SO-IS is the only member that can enter and correct your Navigation Systems activity into AUXDATA and only you can let the FSO-IS or SO-IS if the data information is incorrect.
