No call outs, got my ALAC card renewed.

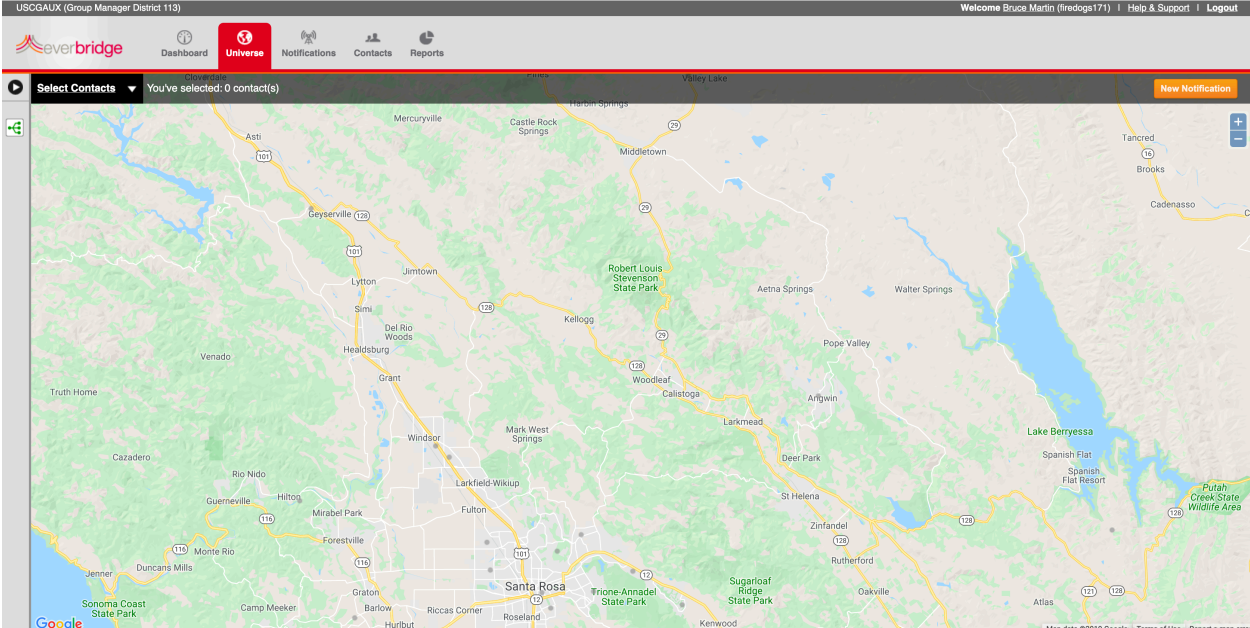
### **Sonoma Fire (Kincaid) Accountability.**

At the request of COMO Kirkwood, between OCT 26 and OCT 30, we made several accountability calls with Everbridge to affected members in the fire area and/or evacuation zones.

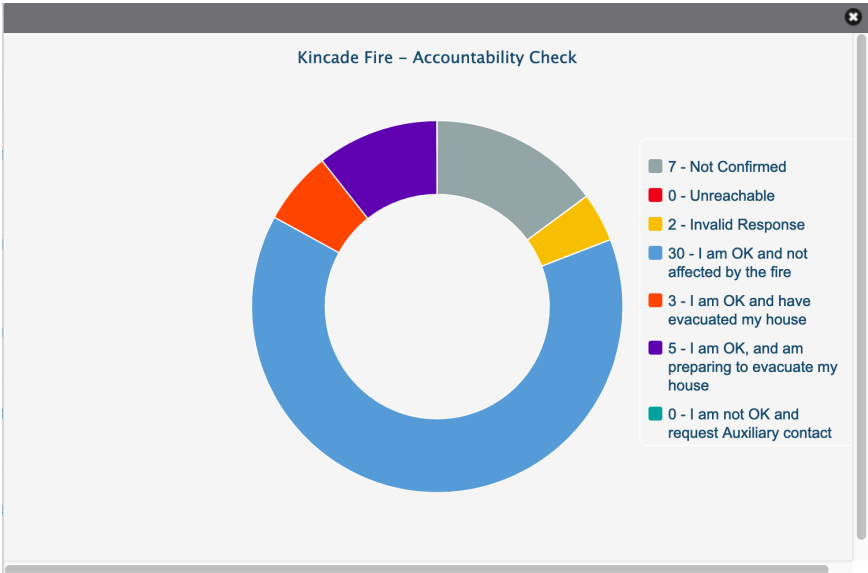
Using the map feature we identified that members who have a PO Box as address in AuxData will NOT come up in the map, so ADSO Bryce Leinan used several other approaches to identify who might have been affected. We worked with National staff to identify and develop a workaround to the issue.

We will continue to refine our capabilities with this tool.

The Coast Guard Office of Emergency Management & Disaster Response (CG-OEM) in Washington, DC is pleased to announce the release of the 2019/2020 USCG Incident Command System (ICS) Certification Board application guidance. This USCG ICS Certification Board is the annual convening mechanism for awarding Type 1 and Type 2 ICS certifications to all members of Team Coast Guard. It is the intent of CG-OEM that all U.S. Coast Guard Auxiliarists working in incident management and

currently **holding USCG Type 3 ICS qualifications** be given the opportunity to present their experience and qualifications to the ICS Review Board for consideration of elevation of their qualifications to Type 2 or Type 1.
