MS Missions

Ferry Boat Exam Status:

Steve Johnson has stepped down as ADSO MS and Thomas Sarnicola has taken the positon as ADSO for the Ferry Boat program. There is a meeting set on December 15 with Sector Prevention to get the Ferry Boat Examination program back on track.

Commercial Fishing Vessel Examinations.

During November 5,6 & 7 Operation Crab Safe, 30 Active Duty, Coast Guard Reserves and Auxiliary visited the major fishing ports in Moss Landing, Santa Cruz, Half Moon Bay, San Francisco, Bodega Bay, Ft Bragg, Eureka and Crescent City and conducted 40 Commercial Fishing Vessel Examinations and 61 Safety Discussions. Some trends seen in the exams show there are many new fishing boat captains with less experience and boats that had issues with life rafts and other safety gear. In spite of our efforts in both the safety exam plus safety discussions, a crab boat out of Ft Bragg went down on Saturday Nov 9 near Bodega Bay. One of 4 persons went missing wearing his PFD but not his survival suit. The life raft was not found. This boat was examined in 2018 so not due until 2020 for the next exam. More to come next month.

Vivian Matuk, recently posted the winners of the 2019 Dock Walker Surveys, Number one was William Hale of Redding flotilla 39 with 532, Number 6 was Jim Golf Sacramento Flotilla 31 with 86.

Abandoned Derelict Vessel Activity

The Abandoned Derelict Vessel stakeholders meeting was held on October 16 in Hercules CA. District 11 Coast Guard requested for the ADV Datebase whick was provided to ERMA, NOAH to be entered into the national database.

Sea Scouts and Marine Safety

Currently the Sea Scouts and US Coast Guard Auxiliary are signing an SOP that covers many concurrent activities. The Sea Scouts have an event, Safety at Sea that focuses on Marine Safety activity and we have a new ADSO that will help in getting the best resources to assist in this event.

The Auxiliary Prevention Outreach Specialist (MEES) and Auxiliary Marine Safety Administrative and Management (MSAM) Training will be held at the January PCA Fair.
