New Webpages Added to District Site

Three new webpages have been added to the District site. First a new "DIRAUX eMail" page has been added. This new page is made from an email that was sent out September 24, 2012 regarding how to communicate with DIRAUX by way of email. Now members can use this new page to refresh how to format email when communicating with DIRAUX.

Next, we added a "District Email" page. This page can only be viewed by members. Here you find items regarding the District's email service.

The final new page is only visible to the District Board and Staff Officers (DSOs) the "District Reports" page. Like the DIRAUX page, is a new page holding the how to instructions for filling District reports. I'm only telling you about this to show off the ability to have pages visible to gorps within the Auxiliary.

When you're looking at the left side menu and you see the small "Ø" symbol it's telling you that, that's a rule based page. Only if you meet the criteria will you see this page. This is the real power of WOW. We started introducing this ability last year with NEWS FLASHES that were target at Members or non-members. If you did not login to the site you only seen the non-member NEWS.

In 2020 we will take this a step forward and add pages or parts of pages targeted at groups within the Auxiliary. The new "District Reports" is just such a page. In this way DSO's can post subjects to members who need to know the information and not cuter up the page for others.

Anytime you expand the logic and ability of something using technology you will run the risk of introducing bugs. Bugs are just parts of the site that don't work as planed. If you do come across a bug just let the District developers know and we fix it. This is just part of the game.
