# MS Missions

Ferry Boat Exam Status:

Nine USCG Aux members met with LTJG Jimmy Crux during the Jan PCA Training fair and discussed the new Ferry Boat Outreach policy and procedures. The 9 Aux members will be assigned in pairs to conduct the Ferry Boat Outreach exams during the months of March and April. There will be only two ferry boat companies participating in this pilot project.

### Commercial Fishing Vessel and Uninspected Passenger Vessel Examinations.

During the N Train, George Peek provided the statistics that the Auxiliary has lost 29 CFVSE examiners nationally last year. The Aux MS teams will need to both recruit and train new CFV and UPV members with inhouse training. He provided the training material for CFV that will be introduced at D Train in Reno. These numbers are followed by the current GAP analysis by Sector San Francisco that has both CFV and UPV as one if their top priorities for this next year

We have also started the UPV outreach program by attending the International Sportsman Expo in Sacramento. Michael Mitchell and Wil Sumner interviewed 2 professional organizations representing fishing charter boats and also visited over 35 fishing guides/charters.

The ADV group now has shared and and is looking forward to an open affiliation with the PACIFIC STATES OIL SPILL TASK FORCE which Includes their Vision of No Spilled Oil; the GOA Report to Congress on "MARITIME ENVIRONMENT. Federal and State Actions, Expenditures and Challenges to Addressing Abandoned and Derelict Vessels.

There will be a change in the USCG Oversite of the ADV WorkGroup Effective our next meeting in May. This will Be ESN Jason Raymond (Jason.C.Raymond@uscg.mil) who has been actively in Attendance for the last year.

### Marine Safety Training

The Auxiliary Prevention Outreach Specialist (MEES) and Auxilairy Marine Safety Administrative and Management (MSAM) Training was held during the January PCA fair with 14 participants in the MEES Training and 9 participants in the MSAM training.

During D Train in Reno, the Marine Safety Team will be presenting two classes: Marine Environmental Protection or Sea Partners, and Intro to Commercial Fishing Vessel and Uninspected Passenger Vessel Examinations.

#### Shoreline Cleanup Assessment Technique (SCAT)

Sector San Francisco will be putting on SCAT training again at the Pacific Strike Team in Novato in March 17-19 2020. This training has only one slot for Auxiliary personnel that have completed IMSEP and the 8 Hour HAZWOPER Training. I will approach NOAA and PST to put on an additional course later this year.
