



The 2020 goal for D11NR is 5,500 VSC's, a 10% increase over 2019. We are 7% of our goal for 2020 year and 30% of 2019 production at this time. The data source is AUXINFO\*. Additional stats from AUXINFO\* indicates that 418 or 89% have passed the VSC, 132 or 28% are First Time VSC's, and 167 or 35% are High Risk VSC's. In addition 45 Paddlecraft VSC's have been performed, which is approximately 9% of our total VSC production. We currently have 170 ACTIVE Vessel Examiners (VE's)\*

\*Current statistics shown in AUXINFO are thru March 30, 2020 which is frozen with AUXDATA II integration and ALL VSC activity has been halted since March 15, 2020 per ADM Gautier.

  - 1. Who accepts an operational facility offer of use and inspection?
    - a. District Commodore
    - b. Flotilla Commander
    - c. Director of the Auxiliary (DIRAUX)
    - d. District Commander
  - 2. Boats registered with states must display the following (Mark all that apply):
    - a. The letter-and-number combination on each side of the forward half of the vessel
    - b. Letters and numbers must be painted or permanently attached
    - c. They must be plain block letters and numbers at least three inches high
    - d. The state validation sticker should be affixed within six inches of the registration number, in accordance with state requirements.

-The Coast Guard Office of Boating Safety issued Policy Letter 20-01. The purpose of the letter is to provide additional guidance to Vessel Examiners on portable fire extinguisher requirements for recreational vessels. Specifically, the Coast Guard now uses a performance-based classification system. This will impact recreational vessels constructed after August 22, 2016. has a guidance letter from CAPT. Johnson to help Vessel Examiners understand the inspection of portable fire extinguishers. Note: these changes are already reflected in 46 CFR 25.30, which pertain to Fire Extinguishing Systems. Federal regulations require all boat manufacturers to place a "minimum number of 5-B portable fire extinguishers" on vessel built after August 22, 2016. This new regulation should benefit vessel examiners to expedite the Vessel Safety Check process Vessel examiners must ensure the 5-B is aboard for all vessels even for PWCs built after August 22, 2016.

Important facts to note:

- 1-This is **NOT** an official VSC, it is **ONLY** for educational/informational purposes, therefore there will **NOT** be any official records or reporting.
- 2-This requires at least 2 mobile communication devices equipped with cameras; to facilitate visual verification of safety equipment and standard safety items per vessel examination criteria. You are **NOT** to be on site!
- 3-The virtual inspection is **NOT** an official examination, therefore the official 7012 and 7012a will **NOT** be used. **No** VSC Decals will be awarded. This is a one-on-one educational exchange and an information and equipment confirmation only.
- 4-Using this link may help with the dialog in conducting a Virtual VSC. It follows the 7012 form.

- 6-Your time will be recorded on the 7029 Form; Section 99 B. DO NOT record any time/numbers on the 7038 form nor submit thru the I.S.
- 7-Provided the owner agrees, you may save the owner contact information for a future VSC and decal award.

## -JUST A REMINDER THAT ALL VSC ACTIVITY IN D11NR HAS BEEN SUSPENDED INDEFINITELY BY ADM GAUTIER.

- -According to AUXINFO, our D11NR Vessel Examiner base has declined from 198 examiners to 170 examiners another 14% drop as of March 1, 2020. I attribute this additional drop from 101 in REYR to the fact that the additional 28 examiners are in REYR due to NOT having taken the Introduction to Risk Management. This makes 129 total Vessel Examiners in REYR
- -NEW-VSC's ON RENTALS-At the request of Commodore Kirkwood, and after 18-years, the VSC Rental Program has been updated for 2019 and moving forward.

  ANYONE who performs rental VSC's on PWC's, fishing boats, houseboats, paddlecraft, etc. MUST be aware of the new changes in effect after 1 June 2019.

-For Coast Guard liability insurance purposes, PRIOR to leaving the house for ANY VSC activity other than to participate at an organized station, PLEASE remember to notify member of the flotilla leadership (FC, VFC, and FSO-VE) of your planned activity. The notification could be in the form of an email, text message or a phone call. In the unlikely event of an incident, be prepared to provide proof of the notification. In addition, per the new VSC Manual please remember, you also need to be in uniform and if boarding a vessel you need to be wearing a lifejacket. Ve test answers 1 "C" see pg 6-1 2 "A, B,C,D" see pg 3-3

#### ALL VSC ACTIVITY WAS SUSPENDED MARCH 15,2020

- -PLEASE do NOT wear boots to climb aboard a vessel to perform a VSC. Our program allows for deck shoes, white or black tennis/walking with soft soles. If this is not an option, please consider purchasing disposal shoe/boot covers available at any the paint, hardware dept. or a Wal-Mart, Lowes, Home Depot, etc. A package of 6 is typically under \$10.
- **-Just** a reminder, per the 2015 Vessel Examiner (VE) workshop, paddlecraft VSC's DO **NOT** count toward the initial VE qualification or requalification. The VSC may be performed a sailboat, powerboat or PWC.



**-A special request** from the Director's office; PLEASE have the qualifying members 7038 with the 5 VSC's entered into AUXDATA by the FSO/SO-IS  $\underline{\textbf{PRIOR}}$  to submission of the MT-2 to the Director's office.
