### Commercial Fishing Vessel and Uninspected Passenger Vessel Examinations.

In talking to Sector SF Prevention, Manny Rameriez concerning Operation Crab Safe, typically done in October, we are making plans to see if this can be done by physical exam, similar to the VE exams.

There are expanded efforts by the Coast Guard to enforce UPV registration and licensing. Both District 11 and District 13 have sent out announcements on their enforcement activity. Auxiliary UPV examiners through virtual outreach efforts can assist in the prevention aspects of this activity.
