From the Deputy's Corner:

Great news - The AUXPA-12 organizers and staff are expecting that there will be a number of opportunities to hold AUX-12 classes in 2022. So, keep a close lookout for what is coming. In the meantime, everyone is encouraged to make use of the great online resources to research and review the Coast Guard and the Auxiliary Public Affairs policies and procedures.

And, if you, or anyone you know is interested in Public Affairs Staff Officer training and a PA staff officer assignment you should work on completing AUX 20, 22, 23, 26, and the ICS 100 programs online.

As always, those Members who do attend the AUX-12 program are fully expected to complete, Asa minimum, the PA 3 Specialist certification program within one (1) year of competing the AUX-12 program.

Social Media - As the use of Social Media (SM) expands, the National Leadership has recognized that not everything being posted on Auxiliary SM sites meets the Coast Guard and/or Auxiliary SM policies and rules. The National Leadership has suggested that all SM postings be vetted by flotilla, division and district leadership and the DSO-PA prior to being posted. In keeping with the D11NR policy, all proposed articles, which does include SM postings, are to be reviewed and approved by the COLM and DIRAUX, prior to being released, and in recognition of the need for timely posting of SM information, a 24 to 48-hour review process is imperative. It is recognized that this will require flotilla, division and district leadership to develop systems that support their member's use of SM.

As District Commodores are ultimately responsible for what is posted on the SM sites within their District, it will ultimately fall on Commodores to always assure compliance with Coast Guard and Auxiliary SM policies, with the assistance and input of Division and Flotilla Commanders, their respective PAOs, and the DSO-PA.

District 11NR Division Commanders are expected to include a report of ongoing Social Media (SM) activities in the Flotillas in their AOR and in their Divisions, in their monthly reports to the District Leadership. The District Leadership has expressed strong interest in all Social Media activity. Division Commanders are expected to report any Division or Flotilla Facebook, or other Social Media activity to the District Leadership monthly report. If there is no SM activity in your Division, report "No SM activity in the Division." This tells the Leadership that Division Commanders are following the SM process and that there is no SM activity in their AOR.

Patrol - September 19, 2021

This is a very brief after-action review and/or evaluation of the above-mentioned patrol.

- 1. This patrol involved a PATON patrol of two bridges in Alameda and a Kite Surfer Safety Patrol for the support of Station Golden Gate STAGG.
- 2. After our Pre-Underway Patrol Briefing, the crew of SERVANT prepared to get underway and made our way over to the Bay Farm Island Bridge and the Bay Farm Island bike bridge to verify them for our annual bridge inspections.

- 3. The crew of SERVANT engaged in 4 SAR cases throughout eh day:
 - a. First: Report of kite west of south tower, which was picked up by the 47.
 - b. Second: Yellow wing foil west of south tower, which self-rescued.
 - c. Third: White and blue wing foil we picked up under the center span.
 - d. Fourth: We were flagged down by a kite surfer and directed to a kite surfer with equipment failure just inside the center span.
 - e. Our MISLE number for all four cases was 1279043.
- 4. The sea state was very rough with sea swells of from 4' to 7' and wind gusts up to 15+ knots.
- 5. Adam Kovalevsky got several more sign offs in his Boat Crew PQS guide. He will be ready for his check ride during the Div 12 OPTREX in October.
- 6. The crew of SERVANT performed incredibly well throughout the prosecution of all four SAR rescues. Summary (Written by Greg Olsen of Flotilla 113-12-91 and Coxswain in Training) of the four SAR cases follows:
 - a. Summary of Action

On Sunday, September 19, 2021, OPFAC SERVANT (OPFAC 241647) conducted a kite surfer safety patrol in support of STATION GOLDEN GATE (hereafter STA GG). Crew of SERVANT were all Auxiliarists. The Coxswain was James Losi. Crew consisted of qualified boat crewmen Gregory Olsen and Alexander Bennett and boat crew trainee Adam Kovalevsky.

SERVANT entered STA GG'S AOR at 1405 and transferred radio guard from SECTOR SAN FRANCISCO to STA GG. SERVANT transited to STA GG for a briefing at 1435. At 1505 SERVANT was underway to start the patrol. Given the environmental conditions with a strong WNW winds and an ebb tide throughout the afternoon, the patrol would prove to be a challenging one. At 1525 SERVANT was directed by STA GG to proceed to the vicinity of the south tower of the Golden Gate Bridge to search for a kite surfer in distress. On scene no kite surfer in distress was evident on the eastern side of the bridge. Further information from STA GG indicated that the kite surfer was west of the bridge. SERVANT requested permission from the order issuing authority (OIA) to exit the Gate, which was granted at the coxswain's discretion, while STA GG launched a 47-foot MLB to assist in the search.

SERVANT proceeded to search west of the south tower, however the sea state proved hazardous to the vessel and after searching 200 years outside the gate, SERVANT came about and returned to the confines of San Francisco Bay. (STA GG communicated that the kite surfer was found and recovered at 1605 approximately 500 yards west of the Golden Gate by the MLB.)

SERVANT resumed her patrol between the south tower of the Golden Gate Bridge and Alcatraz. At 1550, SERVANT was directed to respond to a call for help from a kite surfer in distress in the vicinity of the south tower of the Golden Gate Bridge. SERVANT arrived on scene and spotted a wing foil surfer in struggling in the wind and waves approximately 100 yards north of the south tower under the center span. That was not the target of the SAR however, and SERVANT proceeded outside the gate to check the west side of the south tower, where a wing foil surfer who had been caught in the eddy behind the tower was able to self-rescue. The self-rescue was reported to STA GG and SERVANT proceeded to pick up the other wing foil surfer in distress under the center span at 1605.

The pickup of the surfer was challenging. The westerly wind combined with the ebb tide to produce treacherous seas of 5 to 6 feet for the 24-foot OPFAC, however, the crew performed with outstanding skill in maneuvering alongside the surfer, recovering his equipment, and the surfer without risking the vessel or crew. The victim was assessed and then transported to Saint Francis Yacht Club. SERVANT got back underway from Saint Francis Yacht Club at 1635.

Two wing foil surfers, one with a black and teal wing, and another with a white wing, located between Chrissy Field and Alcatraz Island refused help even though they appeared to be struggling. Via radio, the 47-foot MLB said that they would keep an eye on them, because they were in the vicinity.

At 1707 SERVANT was directed by STA GG to look for a kite surfer stranded under the center span of the Golden Gate Bridge. The bladder of the kite surfer's kite had popped. SERVANT was on scene in 9 minutes and had safely recovered the surfer and his equipment also in very challenging conditions due to the tide, winds, and swell at the Gate. Recovery took less than a minute and the kite surfer was transported to Saint Francis Yacht Club. SERVANT got back underway at 1735 from SFYC and at 1745 left STA GG'S AOR and RTB at 1830 at Oakland Yacht Club. Note: all SAR activity for the day was recorded under MISLE 1279043.

The crew performed admirably in very challenging conditions on this patrol including: the helmsman maneuvering the 24-foot boat in strong wind, waves, and swell to recover persons in the water, the lookouts picking out victims in swell at long distances, excellent radio protocol during the SAR evolutions, and the deckhands performed efficiently and safely to recover equipment and people under extreme conditions for the vessel.

- 7. We now have a signal system for each SAR case the crew of SERVANT is involved in. Thus far, SERVANT and crew have had eight SAR cases. Picture attached.
- 8. We covered approximately 52 NMs during the patrol. Figures 1 thru 3 illustrates our






FIGURE 2 - PART 1 OF PATROL TRACKING. SPYTECH TRACKER






