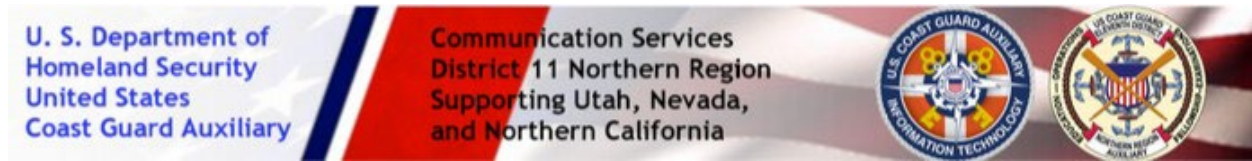

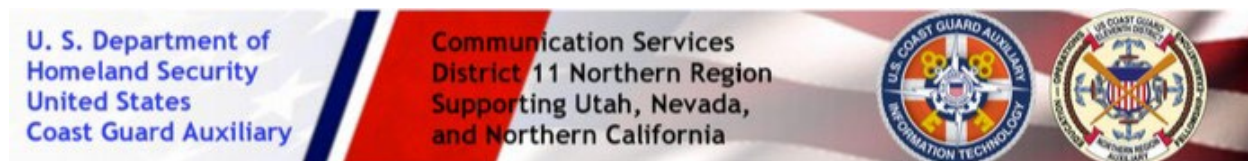

CS Items of Importance

- Received an invoice from the In-Motion web hosting company for the domain registration (1 year) of the **d11nr.uscgaux.info** domain. The invoice was in the amount of \$17.99 and was forward to the DSO-FN for payment. The invoice has been paid by DSO-FN.
- Renewal of the web hosting services (VPS-2000HA-S) for 2 years will be coming due on 04/07/2022 in the amount of **\$2,039.76**. The services are for the **d11nr.info** domain (primary domain) which supports all of the web activities for D11N.
- Renewal registration for the **d11nuscgaux.info** domain and domain privacy will be coming due on 04/07/2022. The domain registration for 1 year will be \$17.99 and the domain privacy for 1 year will be \$12.99.
- Renewal registration for the **d11nr.info** domain and domain privacy will be coming due on 9/22/2022. The domain registration for 1 year will be \$17.99 and the domain privacy for 1 year will be \$9.99.
- Receiving automated notifications from the hosting company that our SSL certificate(s) are about to expire on January 18, 2022.
 - The hosting company has informed me that the SSL (Secure Sockets Layer / Transport Layer Security (https)) certificate(s) should renew automatically for hosting service without cost, but they have not automatically anytime during the past week (1/7 – 1/14/2022).
 - Currently monitoring the status of SSL certificates to ensure that they do automatically renew and that the D11N website will support secure sockets.
 - Will notify leadership if has been determined that renewal of the SSL/TLS certificates will incur any renewal costs.

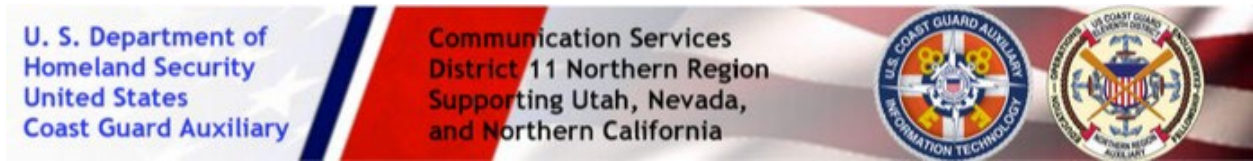
