



## **V**PAC AREA Statistics



Due to the current conditions, there is no VSC goal for 2021 in D11NR. The data source is AUXDATA2\*. Additional stats from AUXDATA2\* indicates that 1241 or 83% have passed the VSC, 763 or 51% are First Time VSC's, and 651 or 43% are High Risk VSC's. In addition 277 Paddlecraft VSC's have been performed, which is approximately 18% of our total VSC production. We currently have 195 ACTIVE Vessel Examiners (VE's)

# **VSC** Questions

- -These are actual questions from VE Exam Version "E" dated 2014. Answers can be found in another location in the report.
- 1. What is the requirement regarding a sound producing device for paddlecraft?
  - a. There is no requirement.
  - b. Some means of making an efficient sound signal (athletic whistle acceptable).
  - c. Whistle required only when operating between sunset and sunrise.
  - d. Some means of producing an efficient sound signal when operating in the vicinity of power-driven vessels.
- 2. If there are multiple member owners of a facility being offered for use the 7-digit member ID entered on the 7003/7008 is:
  - a. The member who will be designated coxswain.
  - b. Any member who is a part owner.
  - c. The member holding the largest percentage of ownership.
  - d. The member holding the highest elected/appointed office.

### **Vational** and District News

#### **Vational** News

"Responding to a "Help Desk" question concerning VEs on recreational vessels more than 65 feet in length, the following clarification from the Coast Guard's Boating Safety Division was reached. Auxiliary VEs cannot perform VSCs on recreational vessels over 65 feet due to evaluation criteria beyond the scope of the current VE training syllabus. If an owner requests an exam on such a vessel, they should be referred to the Coast Guard. This will be a topic in the 2022 VE Workshop.

A complete revision of the National Testing Center VE Qualification Exam was completed. During the process, your comments and recommendations were incorporated. All the existing questions and answers were reviewed for completeness and accuracy. Revisions were made, as required. Additional questions were added to verify the potential VE has a current understanding of VE issues and procedures. The exam is been uploaded and should be online imminently. This follows a revision and update to the VE Practice Exam earlier this year.

A reminder that the Vessel Examiner Program/RBS Program Visitor Ribbon is only to recognize VEs and RBSPVs. It cannot be awarded for qualification as a Commercial Fishing Vessel, Uninspected Passenger Vessel, or Uninspected Towing Vessel Examiner. This is because the CFV, UPV and UTV are programs in support of Coast Guard activities while VSC are authorized by Auxiliary Sector Commanders. In addition, the examiners for Coast Guard programs are recognized via the Marine Safety Training Ribbon. A recent manipulation of the email functionality of the "I Want a VSC" occurred resulting in the system being taken off-line until the situation can be corrected. There was no data breach. You will be informed when the situation has been corrected."

NEW-Just a reminder that now that AUXDATA2 has been updated, the 2022 VSC decals will be shipped by mid-January to the FC or DCDR of record.

- -PLEASE do NOT wear boots to climb aboard a vessel to perform a VSC. Our program allows for deck shoes, white or black tennis/walking with soft soles. If this is not an option, please consider purchasing disposal shoe/boot covers available in the paint or hardware dept. at Wal-Mart, Lowes, Home Depot, etc, a package of 6 for under \$10.
- -A special request from the Director's office; PLEASE have the qualifying members 7038 with the 5 VSC's entered into AUXDATA by the FSO/SO-IS <u>PRIOR</u> to submission of the MT-2 to the Director's office.
