**Goals: 1.** Provide excellent contingency communications in support of Coast Guard District 11, Sectors and Stations through continuous training and education.

## **HIGHLIGHTS/"3 UPS":**

- 1. AUX OP CM course is completed. Thank you Doug McPherson for leading the course and Chris Lay, Kevin Sellstrom for assisting.
- 2. Ventrilo VHF link is working well. I will send out invitations to SO-CM team in an attempt to have at least one member from each division participate in our weekly net.
- 3. On line training for the Vara HF/VHF modem went well. Over 50 members from several districts attended the repeated sessions. Thank you Bill Scholz and Ray Montagne for hosting the training.
- 4. I called all SO-CM and requested monthly reports and encouraged division specific training.
- 5. I attended the Quartzfest amateur radio event in Quartzite AZ and met with D11S member Gordon West who presented a summary of USCG-Aux Communications programs to attendees.



# **Highlights/ DOWN:**

1. Mt Diablo repeater is still down. We are attempting to gain access to the security fencing around the repeater hut. This is CG controlled. The system failed following a restoration from CH 16 to normal mode. The radio gear is approximately 20 years old and the batteries are likely worn out. <a href="Update:">Update:</a> I have been in contact with National Branch and have requested direction in obtaining a surplus Coast Guard radio gear. I also stressed our direct support of Sector San Francisco and VTS. Kevin Sellstrom is in process of scheduling a service call to the Diablo site to evaluate the current problem. Again, our repeaters are very old and in need of replacement.

# **Highlights**

- \* Station called out **John Hardin** and AUX vessel **Sidekick** with **Greg VanKoersel** on December 30<sup>th</sup> to provide security zone for recovery of vehicle in the water with deceased occupant near Clarksburg on the Sacramento River. Again on the 17<sup>th</sup> of January with **Don Anderson** for a partially sunken boat just south of Pioneer Bridge. Thanks again guys. Always ready and able.
- \* **Flotilla 5-3,** in conjunction with the Park Rangers, installed a new and improved life jacket stand at Sandy Beach on the 23<sup>rd</sup>. Thanks folks. You may very well save some lives over the coming year.

## **Activity Details:**

- \* CG Station Rio Vista conducted **06 SAR cases** during the last 30 days. The average January SARs over the last 15 years is 12. The most SARs conducted by the Station in one month was 70 in July 2009. The Station conducted **17 vessel boardings**. The average January boardings for the last 09 years is 12. The most boardings conducted in one month by the Station was 149 in September 2015.
- \* In an effort to stay in front of further **governmental COVID requirements**, I provided a copy of my fully vaccinated and boosted COVID-19 record from Sutter Health, a signed Attestation Form for Certification of Vaccination, a copy of my COVID High Risk Assessment Form and a January 2022 completion report for Blood borne Pathogen Awareness to the Station's OIC **BMC Bennett** and **DIRAUX Office.** Let me know if any Auxiliary Official needs or wants copies. In addition, I have obtained an N95 mask to wear at the Station when within six feet of another person. Other suggestions anyone?
- \* Stood 12 days of **Radio Watchstanding (20B)** at the Station for a total of 84 hours and participated in 03 SAR cases. Missed a couple additional days due to eye surgery.

#### **Continuing Notices**

- \* Auxiliary members are always permitted on the Station in uniform (ODUs or Trops) but must be fully vaccinated. (See Auxiliary COVID-19 Reconstitution Guidance Version 3 for details). A mask on Station is required indoors when within 6 feet of another even with a completed COVID-19 vaccine. Give me a call to arrange a group tour. I'd love to show you around. - \* The Station has permanently schedule two days per month for two boat drills with the AUX facilities in Div 3, 5 and 10 in Station's AOR. The days are the second Wednesday and the third Saturday. These are now included on the Station's training calendar. - \* Onsite interactions with CG Station personnel are highly recommended and sought for any excuse you can think of. Radio Watch standing is a recommended approach I've used over the past 14 years. It will pay big dividends for the Station and yourself.
