

This report covers surface activities for the month of February which is the first full month that we were "back in business".

DETAILS

- 1. The "Antlers OPTREX" at Lake Shasta has been a tradition for well over 30 years. It has been on hiatus for the past two years due to the pandemic. There has been speculation that the event would not occur in 2022 due to low water levels in Lake Shasta and an insufficient number of organizing members. Several members, including at least four Qualification Examiners, are planning on holding the event nonetheless! We are seeking boats, crews, candidates for qualification, those interested in training, and (importantly) those interested in one of the best Fellowship events of the year. On-the-water activities will likely be held on Whiskeytown Lake ... a short drive from Antlers Resort. Multiple shoreside training activities are planned and will be held in the Antlers Resort clubhouse (ours for the weekend). A registration form will be sent to all members within the next few days. It is important that we retain this annual event and not allow it to go "D.I.W.".
- 2. The 2022 Operations Workshop and TCT Refresher courses are NOT waived for 2022. The Ops Workshop is available on the RESPONSE Directorate page on the National website and must be presented by an Auxiliarist qualified in the boat crew program (Coxswain is recommended). The TCT Refresher must be presented by an authorized Auxiliary TCT Facilitator. The TCT Refresher will be offered at D-TRAIN starting at 1400 on Saturday. Training webinars will be offered online in the very near future. Both Workshops are required to be completed by 30 June.

Cutterman's Corner

The Coast Guard Core Values

The first thing that I noticed when I first came aboard CGC ASPEN to begin training to qualify for my Cutterman badge, was how differently the Coast Guard and the Auxiliary treat the Coast Guard Core values. In short, the Auxiliary is good at reciting the words while the Coast Guard walks the talk.

Whether it is boot camp, the academy or OCS, new arrivals are introduced to the core values early on, and the meaning and implementation of those words are regularly emphasized and encouraged.

The concepts of the words honor, respect and devotion to duty are simple and straightforward. What they imply is for everyone to behave properly, treat others properly and do your job, whatever it is, the best you can.

These values, which put people first, are unusual for any organization, especially an armed service of a federal government. But the Coast Guard is a most unusual armed service. It is the only one that trains its members to save lives, not take them. This attitude is vastly different.

I enjoy talking with new non-rates when they come aboard a unit with which I'm working. Usually, they are just out of boot camp. I always ask them why they joined the Coast Guard, and usually get the same answer. They joined because they want to help people. Soldiers and marines don't say that.

Unfortunately, the Auxiliary falls short when it comes to practicing what it claims to value. For example, one thing that I have experienced is that too many Auxiliarists do not respond to emails. It happens to others to whom I've mentioned it as well.

I bring this up not to preach or lecture, but as a reminder of the importance of honor, respect and devotion to duty, and to encourage thinking about what these words mean and to work toward putting them into practice.

News from YBI

On 29 November of 2021, CGC ASPEN left YBI for the last time, after being home ported there for nearly twenty years. She has arrived at the Coast Guard Yard, in Curtis Bay, Maryland, where she will undergo a major overhaul before traveling to her new home port in Alaska.

CGC ALDER, a sister ship, is presently undergoing her major overhaul and refit in the same yard, and sometime next spring will make her way to YBI as ASPEN's replacement. After spending 18 years home ported in Duluth, Minnesota and 18 winters breaking ice on the Great Lakes, the California coast and milder winters should be a welcome change.

Next spring, ASPEN's old crew will become ALDER's new crew and will bring her to her new home port, San Francisco, where she will become one of the two buoy tenders attached to District 11. In the meantime, buoy tending duties will be handled by the other D11 buoy tender, GEORGE COBB, who is no stranger to Northern California waters as she is up here twice a year to maintain buoys in the shallower Delta waters, and also serves on alternate years for Fleet Week duty.

Details:

- 1. Practice and prepare for yourself for surface operations and for requalification with a QE this summer. The standard is that you must be proficient and able to do all tasks without prompting or hesitation. Since we will all be a bit rusty, here are some suggestions that you can do now while our water is still frozen solid.
 - a. Review line handling commands.
 - b. Practice your knots. There are some nice free knot tying apps for your electronic device that show animations of each knot. Suggest that you download an app and practice the five required knots and then learn a few more. Know the Square (reef), bowline, round turn and two half hitches, clove hitch, and sheet (becket) bend knots so you can demonstrate them without hesitancy.
 - c. Review the coxswain or crew or PWC check ride qualification tasks on respective qualification guide found on the National website.
