**Goals:** 1. Provide excellent contingency communications in support of Coast Guard District 11, Sectors and Stations through continuous training and education.

## **HIGHLIGHTS/"3 UPS":**

- 1. D11-CCNET was held, over April 23 weekend. The event sites were: D11, Sector SF, Sta. Monterey, Sta. Tahoe, Sta. and Sector Humbolt Bay as well as relay stations in Boise ID and Southern California. The event was held from 0800 hrs to approximately 1500 hrs. I am happy to report the exercise was very successful with 100 percent of HF-VHF traffic passed to the addressed stations. Several lessons were learned and will be addressed in a detailed after action report. The exercise was observed by D11(dt) CDR Jojola and D11 Command Center Chief \*\*\*. The team received good evaluations as too our capabilities in support of the Coast Guard. We plan to hold quarterly exercises to build on our skills. ## **Report Details:**

The ACV was requested to be on display during a large open house event on Coast Guard Island, which was attended by potential USCG candidates, dignitaries, and various other service personnel. The ACV was on display on April 22, 2022, from 0700-1130 hours. LCDR Ruth Sadowitz expressed her sincere gratitude for the participation of the Auxiliary. The ACV team was FC Stephen Busch, 113-12-91, and Bob Torio, FSO-CM, SO-CM, 113-12-01.

After the event, the ACV and team immediately deployed to Station Monterey in preparation for a major communication exercise and test on April 23, 2022. Other Auxiliary communications facilities were deployed to Coast Guard Island (exercise Command Center), Sector San Francisco, Station Lake Tahoe, Sector Humboldt Bay, Station Humboldt Bay, Station Lake Tahoe, along with relay stations in Cascade, Idaho and Upland, CA.

The objective of the exercise was to test the ability to communicate and pass strategic information in the event of a significant seismic and weather events, where normal communication lines between Coast Guard Sectors and Stations on the West Coast are seriously degraded or inoperative. The exercise was closely watched by the "Gold Side", to possibly include AUXCOM in a more active role in their contingency plans.


