The objective of this meeting was to see what kind of new ideas we, as diversity team members, could come up with on tackling the subject of more accessibility to the Auxiliary by some cultures that not represented in the Auxiliary.
- I was going to volunteer as a AUX Food service worker at the Southwest boarder, but I have been asked if I would not mind instead of volunteering with the AUX Food Service would I be willing to work with the El Paso, Taxes warehouse, logistics support team. Approval still pending.

Division 1

- Presented a wonderful Water Safety Fair on May 21st at Fort Baker. This National Safe Boating Week was very well attended by a large diverse community from the San Francisco bay area, members from flotilla 1-2 and 1-4 use this opportunity to introduce the crowd to the Auxiliary.
- The following inclusion events will be recognized by division one in the month of June: LGBTQ+ Pride month, Juneteenth on June 19th, Caribbean American Heritage month, Puerto Rican Day Parade on June 12th.

Division 5

- After the explosion at Port Chicago, the surviving sailors were ordered to clean up the severely damaged area and tend to their fallen shipmates. None of the 328 surviving African American sailors were given the "survivor's leave" that was offered to the officer. Instead, even though most of the remaining sailors were trained in combat roles, they were ordered once again to continue loading ammunitions at the neighboring Mare Island Ammunition Depot. No additional training was give about loading ammunitions and most felt the working conditions remained unsafe.

Division 12

On June 2nd 1942, in exchange for the right to tax native people, the U.S government unilaterally extended U.S citizenship to native Americans by passing the American Indian Citizenship Act. At this event, I was able to introduce the United States Coast Guard Auxiliary through YouTube videos to interested individuals' that were attending this affair, for the purpose of recruitment into the United States Coast Guard Auxiliary.

- Work strengthening relationships and trust in a diverse community for the purpose of introduction and recruitment into the USCGAUX.
- Recruit different generations of ethnicities, age group and genders to the Auxiliary to increase its membership.
