Mandatory National Instructor Workshop

Currently 79 of our 137 instructors had a 2022 workshop showing up in AuxData. This is a compliance rate of 58%, up from 45% last month.

Instructors are required to complete the workshop by 30 JUN 2022. Instructors who do not have a workshop entered into AuxData by then will be placed into REWK status. Instructors who do not have a workshop entered into AuxData by 31 DEC 2022 will be placed into REYR status. The workshop can either be studied alone by the instructor or – even better – taught by an instructor to one or more instructors (earning the teaching instructor some MT instructor hours!).

National E Directorate Meeting

On May 19th I attended a meeting of DSO-PEs hosted by the staff of the national E directorate. We discussed upcoming projects and priorities of the E directorate and spent a substantial amount of time discussing how to increase the number of nominations for the Commodore Daniel Maxim Award for Excellence in Education. While our district has made timely nominations of this award each of the last two years, not all of our flotillas and divisions have made internal nominations up to district during those years. Those on the call believe that the impact of the pandemic and the resulting decrease in PE activity and the cancelling of the high-profile, in-person awarding of the award at NACON are partially to blame for the low nomination numbers.

All-Instructor Email List

Mike Thompson, our ADSO-CS-EPM, has created an all-instructor email list for our district. This has allowed the DSO-PE office to directly reach out to the district's entire instructor corps. The first use of this email list included a copy of the report from AuxData showing which instructors have a recorded 2022 instructor workshop and which do not. Several instructors replied to this email expressing thanks for being able to see what AuxData had on record for them. More than one instructor replied that they had taken the workshop and were surprised to see that AuxData did not have a record of it. Correcting those records resulted in part of the increase in our workshop compliance rate from May to June.



With that feedback, we will work to provide our instructors with additional reports from AuxData that they might find helpful or relevant to their MT and PE practices.

District PE Goals Snapshot

Our district's 2022 PE goals are: (i) for each division and each flotilla to have a PE officer, (ii) for each flotilla to have a fully qualified instructor (including having completed the 2022 instructor workshop), (iii) for each flotilla to have completed one PE course of any type, and (iv) for each flotilla to have completed one "A Paddler's Guide to Safety" course.

To help the PE department and the District board and staff at large track our progress on these goals, we have created the District PE Goals Snapshot, which is set forth below. In general, green means that a goal is met and yellow means that a goal is not yet met. The one exception is that a missing SO-PE shows up in red.

The goals snapshot reflects only the data that is in AuxData. If you see something that you believe to be an error, please first check AuxData to see if AuxData has the correct data. If AuxData has the correct data and our goals snapshot is in error, please reach out and let us know.

Those boxes with heavy outlining represent the progress made since last month's goals snapshot. Congratulations to flotillas 52, 67, 76, and 8-39 for making progress!
