Subject: Activities Report for May/June/July 2022

<u>Doug Manifold – Deputy ADSO – PA – National Division Chief of Standards & Oral Boards</u> From the Deputy Corner:

The Gold Side is still planning to fund a number of AUX-12 Public Affairs Classes this year and the first one is planned to be in our District in May. We are thrilled that several of our D11N shipmates have been selected to attend this excellent program.

It is up to our District, Division and Flotilla leaderships to follow through with the task of assuring that every member who is, or has been, funded by the Coast Guard to attend this program completes the AUXPA 3, 2 and 1 Public Affairs Training programs and serves as a Public Affairs Staff Officer in some capacity at the flotilla, division or district level.

It is a moral obligation that all members who are funded to attend the AUX-12 program complete, as a minimum, the AUXPA 3 Specialist certification program within one year of completing this C-School. It is also incumbent on all of us to make it a priority to appoint flotilla, division or district PA Staff officers those members who are PA Certified Specialists. And, it is imperative that the members who you do approve to attend the AUX-12 C-School commit to you that they will serve as a PA Staff Officer for a minimum of three years. In those units which do not have members who have attended the PA C-School program, it should be a policy that all PA Staff officers be required to complete an AUXPA Specialist Certification process within the first year of service as a PA Staff Officer.

All appointed Public Affairs Staff Officer positions shall be filled by members who are Certified Public Affairs Specialist. It is better to not have a PA Staff Officer appointee than to appoint someone who is not certified and does not have sufficient Public Affairs training.

As a compromise to only appointing certified PA Specialists to PA staff positions, flotilla and division commanders might consider a provisional appointment of an uncertified member with the requirement that the appointee will complete AUXPA 3 for appointment at the flotilla level and AUXPA 2 for appointment at the division level within three months of the appointment. Failure to complete the required PA training will result in appointment being revoked.

All Public Affairs staff officer appointees at the district level will be required to be certified AUXPA 1 Specialists

Friday, June 17 2022

I attended the Change of Command Ceremony (COC) at the air station. Some of you were there but left before the festivities ended and I thought others of you might be interested in several aspects of this event. Roger Bazeley documented it officially, but I don't know if he ever posts all or most of his photos for anyone to look at, or if you only see one when it is selected for publication. I just took a few shots of special interest.

The Cooper family meant more to some of us than previous COs, and their families who we never met. Several weeks after he assumed command of the air station in the summer of 2019, my flotilla happened to be holding one of our annual flotilla picnics where we brought prepared food to the air station and invited the duty crew and anyone else on station that day to join us for lunch. All we ask for in return is a tour of the hanger, unless the duty crew is off on a SAR case.

On this Saturday CAPT Cooper, his older daughter, Mary Kate, and the family dog happened to be on base as he had some work to complete and they all joined us for lunch where we got to know them more so than would be usual. Herman Haluza got to monitor the family dog while CAPT Cooper and Mary Kate ate and talked with us. Not long after this CAPT Cooper came along on a helo ops patrol on Silver Charm and worked the deck for hoisting. I had him at the helm on the way back to YBI afterwards and we even had a minor SAR case. He seemed to enjoy that! In the helo ops photos, CAPT Cooper is on the left in one photo and CDR McKinney, the Ops Boss, is 2nd from the right he stayed dry! The man on the sailboat was having mental issues and kept demanding to get off the grounded sailboat immediately, and threatening to jump off. We stood by until Station SF sent a RBS.

This COC/retirement ceremony was different from others that I recall. I've been fortunate to be invited to all of them since Silver Charm started working with the air station in 2000 (usually every three years). They went through the formal activity of handing command from CAPT Cooper to CAPT Huberty with Rear Admiral Penoyer (D11) presiding. I didn't notice it at first, but all the active duty then drifted off and came back having changed out of their trop blues, or dress whites, into flight suits or ODUs for a few. They were going to be more comfortable than we guests, still in trop blues or appropriate civilian attire for family guests.

CAPT Cooper has an identical twin brother who took over as master of ceremonies. Both are graduates of the Coast Guard Academy, but his brother retired a few years ago and had fun kidding his brother about now being able to grow a beard as he now has. It wasn't mentioned on Friday, but CAPT Cooper had alluded to the two of them being misidentified as the other while at the Academy with funny outcomes. Another important member of the family also came out, the family dog. He looked a bit older than I recall him from three years ago with some white around his muzzle. What was so funny and also enjoyable was he would lay quietly until there was applause, on many occasions during the speeches, when he would become very active and start barking. Otherwise he seemed happy to doze at the CAPT's feet.

Some of the other different activities included CAPT Cooper's wife and two daughters all being presented with certificates by Admiral Penoyer. I didn't quite hear how they came about, they might have been Admiral Penoyer's doing, or even Admiral Fagan's. The admiral gave a very moving speech

about the importance of the spouses and families of military members, of all the services, not just the Coast Guard and elaborated on the hardships they face. I later told him he could go on a one person tour of Coast Guard installations making that speech to families as it would likely spur retention, one of the perpetual problems for all the services along with recruitment. I also have to mention that once again Rick Pisio's famous photo of the AST with the setting sun and the Golden Gate Bridge in the background was used in the COC program. The large version hangs in the wardroom but they use it in every COC program since it was taken, must be three or four now.

The older daughter made a very impassioned speech about her father and what he meant to her and her sister as they grew up. Mary Kate has graduated from Stanford and will attend Oxford for a program in astrophysical/aeronautical engineering. In 2019 she was a "walk-on" for the Stanford women's rowing team and they were the PAC-12 champions for 2022. She has a good memory as she stopped and talked with Cassandra, as they have rowing in common, having discussed it at a holiday function several years ago. You can tell they are a very close and loving family. They will take up residence in FL. CAPT Cooper has 28 years in the CG. He had a major role while stationed at USCG Air Station New Orleans during Katarina.

I'm attaching five photos I took which show the family dog for those who like dogs and several others of the unofficial activities. Those who left early missed the light lunch and nice cake prepared and served by our own AUXCA folks. In several of the photos you may notice that CAPT Cooper somewhat severely damaged his foot while playing hockey on the ramp a few days ago. You may also notice Mary Kate has an artificial leg. She never seemed reluctant to let people see it the handful of times I've seen her over the past three years. Then there are several photos of the CAPT on our helo ops patrol.

The operational facility #474 (Sundiver) completed two patrol days during May. May 21st was a MOM patrol and Aux training.

May 28th the #474 provided safety support for the annual Memorial Day Hoe WA'A Outrigger races. The outrigger race was a successful event with over 40 outriggers competing in three different race series.

Prior to the start of the first race, the #474 crew responded to a scuba diver in distress at San Carlos Beach. Upon arriving on station, the diver in distress was being helped onto shore and was received by the Monterey Fire Department emergency responders.

At approximately 1345 hours the 201474 responded to the location of a 21' cuddy cabin power boat that was DIW. The DIW vessel was approximately 1.5 miles off Lovers Point in Monterey Bay. All 4 POB were asked to put on lifejackets, and it was determined that there were no medical concerns. The #474 provided a stern-tow back to Monterey Harbor. Upon arrival at the harbor area, the harbor patrol vessel took the DIW vessel in side-tow and moored at the Monterey fuel dock.
