CDR Allegretti expressed to me, and I agree, that this Bodega Bay Community "Takeaway" is most likely similar and worthwhile for consideration for our entire AOR's Communities.

The Community was clearly asking that We of the AUXILIARY be more visible and present.and Yes I know many of us are. Not only inspecting various classifications of Vessels.....But Also offering Courses on All Aspects of Boating Safety .... They are Inviting us to be more Present supporting them with All forms Safety Education as well as in this particular circumstance, supporting US Coast Guard Station Bodega Bay... Let's Not let them down .

**One New Point I will repeat for this SEP Report**: I was having conversation's after the formal meeting with a few of the CFV Operators. I brought up the Topic of PLB's and Automatic Engine Cut Systems. <u>None of those I spoke with were familiar with the PLB's, and One Captain offered he had the Engine Cutoff...but it was Only Available for Volvo Engines.</u> The Next Weekend the Auxiliary held a VSC and PA Day for the Bodega Community and they were able to Provide information on both PLB.s and their Functions and the New Guardian Engine Shut off and Crew Monitoring System which I had forward them.

I will also Repeat my Agreement with CDR Allegretti's Remarks to me in our follow-up After this Community meeting...."That if One Community we serve is asking for our increased Presence and Assistance. So likely are All of the Communities we serve as Auxiliarist".

## I again am extremely pleased to share that DCOS Curtis Han along with (AUC) John Guaraglia and DCDR for the AOR Randy McCormic when initially were invited by Sector, were willing to step up and support this mission.

More-so I am extremely Pleased that upon receipt of the Above "Mission Overview" John Responded that the Very Next Weekend his Flotilla had scheduled to conduct VSC's and have a PA Booth in Bodega Bay and interact with the community.

**CDR Allegretti Chief of Prevention S. F. Sector Quaterly Meetings:** CDR Allegretti requested that we meet more frequently than once a year (prior years) with himself, and more frequently as may be needed with his Staff Officers and the DSO-MS. Which has taken place regularly as Reported monthly by your DSO-MS, and has led to New positive working relationships as well as the development in process of several new Opportunities for Auxiliarist to become Certified by the Gold Side to fill, various Mission Support Roles (Noted Below in Following brief) after appropriate Training and Certification's currently under development for both the Gold Side and then the Auxiliary Supporting Mission's of Sector San Francisco's, Approval and Implementation.

We have Developed a comprehensive "Updated" **Specific to Sector San Francisco**, review of Pollution Responder PQS Programs (Active Duty/Reserves and Auxiliary) for future active utilization within Sector San Francisco "Qualified" Auxiliarist Support. Program Certification of Auxiliarist's by Active Duty/Goldside, includes Successful Completion of Modified "SCAT" Training with Orals Board onsite (YBI) with Sector San Francisco Prevention and IMD.

Later this FALL should begin meeting with LTJG Connell to be Develop Sector San Francisco AOR PQS/Training for Auxiliarist Cleared as "Eyes only" Crew members on USCG SF AOR Patrols; Along with "On-Call" Assistance with Aids to Navigation Auxiliarist to evaluate Notices to USCG.

### **Detailed information about the MEETING TOPICS**

1. **"All the Small Things": Microplastics Monitoring and Management (Scott Coffin, Ph.D. State Water Resources Control Board Division of Drinking Water).** California's Environmental Protection Agency is the first government body in the world to require testing for microplastics, including in drinking water, marine waters, animal tissue, and sediments. Dr. Scott Coffin will discuss the state of the science, the agency's plans for monitoring and managing microplastics, and dispel some common misconceptions along the way.

2. \*Priming the Sewage Pumpout: Why We Monitor and How it Impacts Boaters Statewide (Kendal Soriano, The Bay Foundation and Liz Juvera, San Francisco Estuary Partnership). Discharging sewage overboard creates environmental and human health problems, especially in a state with more than four million recreational boaters! To reduce the negative impacts of discharging sewage overboard, boaters are encouraged to use sewage management facilities, including pumpout and dump stations, floating restrooms, and mobile pumpout services. California's Clean Vessel Act Education and Outreach teams in NorCal and SoCal produced two reports this year with valuable insights on sewage pollution prevention, the CVA Pumpout and Dump Station Performance Report and the Boater Sewage Disposal Survey Report. Tune in to hear about key findings and top takeaways.

3. Collaboration for Conservation - Whales off the California coast are experiencing unique challenges, but resources are available to allow anyone to become a citizen scientist and help (Danielle Tentschert, Education Manager, Ocean Connectors). This presentation will discuss the whales that reside off the coast of California, their importance to our marine ecosystems, challenges these whales are facing, and the resources the public has to help with reporting and research.

4.
