## **DETAILS**

- 1. Updated Information & Statistics: Boat crew and coxswains that last qualified in 2017 & 2018 are due for check rides this year (2022). There was some confusion in many Districts around when check rides completed in 2019 would be due. We were informed last year that those check rides would also be due this year which caused some previously discussed major consternation. Clarification of several "ALAUXs" regarding this subject was very recently offered that corrected the due date for check rides completed in 2019 to 2023. This alleviated pressure on many to get those check rides done this year. As of 30 September 2022, the number of members still due for check rides this year stands at 61 not including initial qualifiers. Of the 197 total of crew & coxswains, 44 (or 22%) are in REYR / REWK status and may not be seeking requalification. Please see the "QE Checkride Due Dates Report" as of 30 September posted on the Response / Surface page on the District website. If a member will not be seeking requalification, please let me know as soon as possible so that the Report may be kept accurate.
- 2. It's not too early to reserve dates for the 2023 OPTREX season. Upcoming OPTREXs currently listed on the District Calendar are below:

## A.3. Effective Communications

Effective communication is essential to the success of the boat crew and their missions. Communications between the coxswain and boat crew members helps to form highly efficient teams, mitigates unnecessary risk, and promotes collaboration between members. A boat crew that works together achieves high productivity, safe and effective boat operations, and, most importantly, a successful mission outcome. Additional communications between the boat crew, Sector Command Center, on-scene coordinators, and other key partners can provide proper coordination and continuous mission progression.

#### <u>Boat crews should always communicate their observations and concerns or ask questions to</u> the others on board, and repeat-backs should be used to ensure understanding.

Everyone on the crew has a role in the decision-making process and must be allowed and encouraged to communicate openly and to provide recommendations regardless of their position, pay grade, or individual tasking.

- 1. Surface Operations-September 2022:

- ii. Perimeter control for the Alcatraz swim event on the 24<sup>th</sup>
- iii. A combined PATON mission and served as a static display at a Sierra Point YC open house at the Brisbane Marina on the 25th.

## 2. Fleet Week Preparations: 06-09 October 2022

- **a.** OPFAC SEAHORSE will be participating in all four days of Fleet Week (Oct 6-9) and September was filed with preparations for that event.
- **b.** OPFAC SILVER CHARM will be out for all four days of Fleet Week. COX Terry Blanchard is the Fleet Week Surface Operations POC and has confirmed that seven OPFACs that will be out this year, including Peter Shamray's SEAHORSE and Tommy Holtzman's SHADY LADY as the two tarp boats.
- 3. **AIR STATION SF SUPPORT-Schedule Change:** After several years on a Wednesday training schedule with an on-scene time of 0915, OPFAC SILVER CHARM'S work with the air station has been switched to Thursdays with an on-scene time of 0900. Changes in the day/time always come at the request of the air station. SILVER CHARM will participate in HELO Training patrols, the last three Thursdays of October.
- 4. **Fiscal Year Orders Changes:** The transition to the new federal fiscal year means for now, all patrols for the month of October will be under verbal orders. Once the accounting strings are loaded, we will be asked to go into ADII and request orders for the patrols already completed, they will be approved, and then we will go back in as usual and enter our claims. This is a temporary delay due to the change in federal fiscal year and is not expected to be lengthy.

### **Goals:**

- Rotating members into training patrols for OPTREX preparation and building underway hours.
- Providing training opportunities for our current crew members and initial qualification candidates.

It will require the closure of portions of these rivers from 0600 to 0900. Local fire, police, and sheriffs' agencies as well as the Coast Guard and Auxiliary will assist in the river closures.

#### **Details:**

- 1. Mini OPTREX on September 24<sup>th</sup> at Jordanelle. One coxswain and one crew member will have a qualification session with Como Mike Williams as the QE and Kevin Woodruff as our AuxComm; Z-Boat and Challenger 76 will be the facilities.
- 2. No order will be approved until further notice due to changing over to new Federal fiscal year which starts October 1<sup>st</sup> (taken from ALAUX 032/22 dated 15 SEP 2022). You will be notified when order can be taken out but for us, most likely after our season is over. All open FY22 orders will be cancelled if not closed out by September 29<sup>th</sup> (ALAUX

028/22). So don't lose your credit and reimbursement for a patrol because you didn't finish your orders.

- 3. When you are finished surface operation for this season, inspect and do any maintenance on your PPE. Then let your materials officer know what have and that you want it taken out of service. Then next spring you can do the same and bring it back into service.
- 4. Our boating season is almost done. Those with facilities, take this opportunity to do get your facility inspection done now so there will be no issues in the spring when we are anxious to get on the water. Take pictures of the facility from all four corners. These will need to be attached to the facility request in ADII.
