The May REYR processing resulted in competencies for three members being placed into REYR status for not completing the Annual TCT/RM Refresher.


AUX-10 C-School

We have four members from our district attending the current AUX-10V C-School!


2023 Annual Workshops

In the ALAUX 002/23, BSX announced the requirement for the 2023 Annual Workshops to be completed by 30 June 2023. Below are statistics of where our members stand regarding each of the program areas that require a workshop as well a link to the AUXDATA II Quick Stop report you can use to show up to the minute information about workshop attendance. These reports have the member's email address so you can easily make contact with members about the 2023 workshops.


Clicking on the link will bring you to a 'generic' report page that shows 'No Results', this is normal! To show information for your Division, Flotilla or the entire District,



Click on the funnel icon in the upper right corner. In the menu, locate the 'Unit Number' filter and click "Change_to_Unit_Number".



Delete the words "Change_to_Unit_Number" and replace them with the Unit Number you want the report to show results for. For the district, enter 113, for a Division, enter 11301 (for division 1 for example) or for a flotilla, enter 1130708 (for flotilla 07-08 for example). Do not use dashes.



Then click 'Apply'. The resulting report will show members with the competency who are currently certified, in REYR or REWK, and it will show if they have completed the required workshop and the date it was completed.

<u>Air Operations Workshop</u> 0 of the 22 members in the Air program have completed the Air Operations Workshop.

<u>Culinary Assistance Specialist Sanitation Workshop</u> 6 of the 33 members Culinary Assistance program completed the Sanitation Workshop.

<u>Instructor Workshop</u> 57 of the 137 instructors have completed this optional Instructor Workshop.

Operations Workshop 85 of the 134 members with the Coxswain, Boat Crew, PWC Operator or PWC Operator in Training competencies have completed the Operations Workshop

<u>Telecommunications Workshop</u> 19 of the 50 members with the TCO competency have completed the Communications Workshop.

<u>Vessel Examiner Workshop</u> 67 of the 125 members with the Vessel Examiner competency have completed the Vessel Examiner Workshop

<u>Annual RM/TCT Refresher</u> This AUXDATA II report shows the number of days the member has to complete the <u>Annual RM/TCT Refresher course</u>.

87 members are current with the Annual RM/TCT Refresher course.

41 members are current with the Annual RM/TCT Refresher course but are due in 180-365 days.

84 members are current with the Annual RM/TCT Refresher course but are due in less than 180 days.

73 members are past due for the Annual RM/TCT Refresher course.

<u>Core Training – AUXCT</u> This AUXDATA II report show the status of <u>Core Training</u> for each of the required courses for members who have completed at least one of the 6 courses. The numbers in the first five columns indicate the number of days until the course is due. The sixth column is for the Ethics course and indicates the year this course was completed. Courses in green are not due for more than one year. Yellow indicates that the course is due by the end of the current year. Red indicates the course is past due. Courses in Red with the number 0, indicate the course has never been completed.

558 members are currently AUXCT certified through at least 2024.

75 members are currently AUXCT certified but will need at least one or more courses by 31 December 2023 to remain certified.

237 members are currently in REYR for AUXCT because one or more Core Training courses are past due or have never been completed.

This AUXDATAII report shows the 133 members who have not completed any <u>AUXCT courses</u>.
