- 4. <u>Mission Activity Codes and Descriptions</u> There has been some apparent confusion as to which Mission Activity Code to use when entering operational and/or operational training hours in AUXDATA II. In **December 2022**, an updated Mission Activity Code list was posted on the National Website that included expanded and added codes. The new list can be found by going to the National Website / "Aux Members" / "Forms Warehouse" / "PDF Forms" / "7030 Mission Codes and Descriptions".

The most often used surface operations codes are as follows:

- 01A MARITIME OBSERVATION (MOM)
- 01B TRAILERING
- 01C PADDLECRAFT
- 01D OPERATIONAL STANDBY

For a full description of the use of each code, refer to the "7030 – Mission Codes and Descriptions".

Three of the operational mission codes have sometimes been misused. A full description of each follows:

<u>22A OPERATIONS TRAINING (QUALIFICATIONS) (A, B)</u> – Hours spent underway on training missions involving surface/air operations, by coxswains, pilots, and crew, who are not IT qualified, which are not otherwise reportable as a Safety Patrol, CG Operational Support, or Member Training mission. (Ref. 01A, 06A, 06B, or CG Operational Support)

• Note – All 22A hours count towards the initial/currency maintenance requirement for underway hours, however per ALAUX 031/22 only up to 15 training hours for on-thewater surface operations and up to 8 training hours of airborne aviation operations while assigned to duty, count towards the Annual Operations Service Award "O" device.

<u>22B OPERATIONS TRAINING (A, B, R, U)</u> – Hours spent NOT underway on surface/air operations training by coxswains, pilots and crew, who are not IT qualified, which are not otherwise reportable under Member Training. Also for use by Land Mobile Operator or a Unit Mission.

<u>06A OPERATIONAL TRAINING</u> – Hours spent as a qualified instructor for any Operational Member Training activity including boat crew mentoring and presenting the Operations/Air Workshop.

As noted above, the updated "Auxiliary Mission Activity Codes and Descriptions" has been updated and expanded. The list of codes includes one or more codes ... sometimes many ... for each of the following Mission groups:

Rescue & Survival Systems (RSSO) Report

Members returning unused Boat Crew gear and kits (kits=complete gear bags) has become a steady stream over the last month. That's the good news. The only problem so far is that in several cases, the gear is returned in very dirty or otherwise poor condition. Occasionally, some wearables are unusable given their condition and have been necessarily destroyed. We have

had several kits returned in unused condition as well. Several kits have been turned in with various items and paperwork missing.

Due to budgetary shortfalls, PLBs are frequently not in inventory. Members should check the battery expiration date, as this can be before the unit expiration date. Members are requested to give the RSSO a four to six-month "heads up" on when the battery expires to facilitate a timely replacement. In the past, D11S's RSSO (William Shakespeare) has been able to loan us some of their PLB inventory, but this should not be counted on, as they also have a limited supply.

As of 09 MAY, our current inventory of PLBs is 13 units. Our OTO, BOSN2 Perez is researching a new system to register and account for PLBs. John Fortner (1-4) is tasked with entering all PPE in AD2. All members will have their equipment entered, and the flotilla still needs to inspect gear and maintain individual maintenance records.

The PPE ordering page is scheduled to go operational by mid-June. It will be linked to the District main web page for FCs, MAs, and/or OPs to access to request boat crew or helo ops gear. Dan Glenn (5-2) has agreed to join the RSSO team and has already done a shift in training with me.

Over the last several years, I issued several LED light bars to several facility owners. Recently, Paul Verveniotis discovered that this light bar type is not waterproof—there are no seals in place at any seam and even gaps where water can get into the unit from heavy spray or when washing with a hose. He has a solution involving silicon caulking that should prevent any shorting-out issues. If you have one of these light bars, please contact Paul ASAP for advisement.

DETAILS

- 1. All operations personnel should perform an inspection of their issued PPE prior to our boating season. Pay special attention to the PLB and check to see the expiration date. If the battery is close to expiring or your unit fails a test it should be replaced as soon as possible.
 - The OTO has requested that members that have issued PPE and don't plan on being active this season or plan on dropping their quals to please return their PPE so that it can be re-issued.
- 2. The good news is we have plenty of water this year. The downside is the water temperature today is 44 degrees. That still puts it in Dry Suit conditions. It does look like with the warming trend, even with the water under 50 degrees, the air temperature will be well above 50 degrees and that puts us into Mustangs
- 3. There are a number of changes that include annual check rides for coxswain, crew and PWC Operators that will be done during scheduled patrols. This doesn't change the 3-year check ride done by a QE. There is also a nighttime element for those members that want to qualify to patrol at night. To see the new sign-off sheets GOTO: Forms Warehouse Home Page. GOTO: Boat Force Forms. Look at: Enclosure 4 and 5. We will discuss this more during the OPS Workshop in a couple weeks.
- 4. I will be holding an OPS Workshop via ZOOM on May 10, 1900 hours. Log-in information will come out the first week of May.
