## Division 1 – FSO-PA – Marisa Hoke




July 2023 PA activity District 11N, Flotilla 113-12-91

Upon meeting Jim on Servant at 11:00, the crew of 4 Auxiliaries completed the risk Assessment and departed toward San Francisco through the Oakland Estuary. Morgan took the helm as the crew went on to practice docking, knots tying, and side towing activities along the way.




Side towing practices led to various random scenarios to familiarize the crew of potential interactions with various boaters and their situations. During this exercise, Jim played various characters of the type of boaters the Auxiliary may encounter ranging from novices to intoxicated individuals.

While practicing tow line numbering for efficient crew and Coxswain communication, Jim informed us to keep it simple with boaters needing towing as some individuals may not understand specialized words such as Bow, Stern, cleats, etc....












During our dock practice and bow pivotal maneuvering, a family with 3 children approached us with curious minds about our activity. This is a very brief after-action review and/or evaluation of the above-mentioned patrol:

- Engaged in a MOM patrol with the intent to engage in our traditional Kite Safety Surfer Patrol (KSSP) partnering with Station Golden Gate – STAGG. We also engaged in dock-side training, whereby Greg Olsen engaged in training in addition to other topics for Jeff Grave of Flotilla 113-12-91 and Jena Pierre Carjuzaa of Flotilla 113-12-91
- 2. As we transited to our operating area of the navigable waters near the Golden Gate Bridge, Greg Olsen, CIC noticed that sea conditions were deteriorating to dangerous levels. Winds were gusting to 25 knots, a small craft advisory was about to be announced, and swells were 4' to 6' every 3 to 5 seconds. CIC Olsen decided to terminate the patrol due to unsafe conditions.
- 3. While we were all disappointed in having to terminate the patrol due to poor conditions, we all respected the decision made by our CIC, Greg Olsen. It was the right decision to ensure crew and facility safety.
- 4. We transited back to OYC where we refueled at the Oakland Fuel Dock before docking at OYC.





FIGURE 1 - TRACK LINE FOR PATROL OF 30 JULY 2023. PREPARED BY JIM LOSI OF FLOTILLA 113-12-91.
