AUXDATA II System Updates

For the next few days, a major update to the Competency Management System in AUXDATA II is taking place. AUXDATA will not be taken offline during this update. The update is expected to be completed November 16, 2023.

Expected System Behavior During the Update:

- The update will include a complete refresh and rebuild of Member Competency Tasks (MCTs). Seeing MCT records missing during the update will be normal. Do not be alarmed by this!
- User interfaces for Member Competency (MC) and MCT records will be rearranged for an easier visual experience and will display new fields to assist with record management.
- Some Tasks will be temporarily unavailable for data entry during the update. The downtime for affected Tasks should be brief and will be experienced as the Task not being available in the Task Type picklist during Task entry. The Task will reappear in the picklist when any updates specific to it are complete.
- Once the system update is complete, MCs will reflect one MCT per Competency requirement. For Task based requirements, the MCT will reference the most relevant Member Task as available. All other historical records for the same Task will still be found in the Member Tasks section of a Member's record (under the Related tab).
- The Training Management Catalog of the Quick Stop Reports will be replaced with new and improved, all-inclusive Competency Management reports, simplified reports for critical Task deadlines, and reports highlighting new and enhanced Competency Management features.

Once the update is complete, we will see a much improved way to track competencies for members. A result of the update will be improved reporting. Existing reports that use the task and competencies objects may be obsolete, but new reports will be made available in the Quick Stop Reports folder ASAP.

Only 33% of our certified Coxswains, Crew Members and PWC Operators have submitted the Annual Currency Maintenance Task forms for 2023.

- PWC Operator 1 of 4

The tasks on this form are required to be completed by 31 December 2023. If not completed, the member's competency will be placed in REYR status.

The forms for reporting the Annual Currency Maintenance Tasks can be found on the National Forms Warehouse Page/<u>Boat Force Forms</u>. These forms are listed as Enclosure (4), Enclosure (5) and Enclosure (6). When all tasks have been completed and signed off, the form must be sent to the DIRAUX office for processing.

AUXDATA training (AUX-10 C-School)

The next AUX-10 C-School will be an online virtual class. It will run two night a week (Tuesday and Thursday) for seven weeks. The dates are TBD. All IS officers at all levels are strongly encouraged to attend a class. Even if they have attended a class in the past, a refresher course is recommended. Members can express their interest in attending the course by completing the Pre-Registration form found on the <u>AUX-10 C-School</u> page on the U Directorate website.
