The reminder of the work is ongoing and continue for the next couple of weeks. Currently working with the Laurence Boag and Paul Custance, the new DSO and ADSO for VE in updating outdated content and web links.
- Updated corresponding webpages with the photos of the newly elected Board and Staff. The following webpages were updated with new information as requested
