2. An updated CHECK RIDE TRACKER Report is posted on the District webpage ... go to "Response", then "Surface Operations". Currently due for requalifying are 38 members in 2024, 54 members due in 2025, and 22 members due in 2026 (requalified in 2023) for a total of 114 members. Members with due dates beyond this year may request a check ride provided this does not impede those due this year. Please keep in mind that certification

expires at the end of the year and not on the anniversary date of the last qualification/requalification check ride.

- 3. As of 14 February, there are 106 members in "Required Yearly Not Met" (REYR) status. Please review this list in AUXDATA II and let me know of anyone not intending to continue in the surface operations program so that we can maintain an accurate record. Please note that if anyone has a question on status i.e. why a member is in REYR, check with your IS officer.
- 4. Operational Excellence Program Auxiliary Manual, Chapter 11.A.14.a. The Operational Excellence Program provides Coast Guard Auxiliary boat crews with a challenging opportunity to highlight their proficiency and skills, foster teamwork, encourage offers for use of surface facilities, and promote fellowship among operational members. The program is neither mandatory nor meant to replace qualifications or certification requirements. All program participants shall follow the policies and procedures established in the Coast Guard Auxiliary Operational Excellence Program, COMDTINST 16794.4 (series), in order to earn this award.
- 5. "Weekly Wave Farewell" from former Sector SF AUXLO LTJG Rachel Jankelow dated 31 January.

Your selflessness to serve showed me the impact the Auxiliary has on the Coast Guard and its 11 missions, and reminded me why I joined the military. Keep up this amazing display of service! 6. On 01 February we welcomed our new AUXLO/OIA at Sector San Francisco. LT Abigail (Abby) Hamann has a great background in multiple CG missions. After enlisting and 'experiencing' eight weeks at Cape May, NJ, she has experience with Aids to Navigation, Team Machinery Technician, A.A. in Criminal Justice, B.S. in Corporate and Homeland Security, Officer Candidate School at New London, CTJourneyman Marine Inspector, and the Chief of Domestics, Sector San Francisco and she is currently in the Waterways Management Shop

From LT Hamann: "It's very important for me that you know me and that I'm not just a name that appears at the bottom of patrol orders or sends emails saying "get me your PO requests 10 business days in advance...or else". We're a team and I'd like you to feel like a part of that team and not just a means to make up the staffing issue the AD side is currently working through. You all are so much more than that so I hope to make sure you feel that way.

I'm coming in with a little bit of a disadvantage since I was supposed to have an entire year with LTJG Jankelow before I came in as primary; as well as I was also supposed to enter this role with an extra person to help me out. Unfortunately, that did not happen so it's just little ol' me for the immediate future. This isn't going to negatively affect you all-I just wish to be transparent in what's happening with the AUXLO program at the Sector level. The only change I have made that will affect you all for the immediate future is the 10 business day request for POs. I understand that this is a change from the rather previous guidance that came out, but with this is the way that I can ensure that you all receive the POs in time to execute missions. On the plus side, I did have a meeting with senior leadership and I am receiving not one, but two AUXLOs/OIAs! There is going to be a bit of a transition period and I don't expect them to be full-fledged AUXLOs for about a month.

I'm working through a couple FORAC items that will hopefully streamline a few things that I know have been a little wonky. Please standby for additional guidance in the future.

A couple housekeeping items:

- Please continue to submit patrol orders as early as you can
- As well as remembering to upload receipts and correct to actual cost for reimbursements
- Keep an eye on Chatter in ADII
- Ensure the PPE is up-to-date in ADII because I cannot issue orders if PPE is not in the green
- CR runs out on 08MAR so standby for what that means for POs and if we'll have funding available

1. **Surface Operations-JANUARY 2024:** OPFAC SILVER CHARM did three air ops patrols in January 2024, one Paton patrol, and one training patrol in preparation for a three-boat QE event on February 10th.

SILVER CHARM will conduct two HELO Ops in February on the 1st and 8th, then a Recertification QE Check Ride on the 10th. The Standardization Team will visit the air station from March 4h through March 15th. Air ops would only take place on weekdays, and it isn't known yet exactly which days Silver Charm might be needed.

- Two Flotilla 12-91 members have acquired surface vessels we anticipate bringing online as inspected and offered OPFACs later this year.



- January 2024 Surface Operations: Five (5) Surface Patrol Orders were Requested and Approved by OIA. SERVANT completed two (2) and ODYSSEY completed two (2) patrol missions; to include MOMs, crew training evolutions, Annual Task Certifications, and Nighttime operations. One (1) approved patrol was canceled.
- 27 JAN, ODYSSEY conducted a daytime patrol to include training evolutions for an upcoming coxswain recertification.
- 27 JAN, SERVANT conducted Nighttime navigation and MOB certification signoffs.
- 28 DEC, SERVANT and ODYSSEY conducted two boat towing and training exercises to prepare for upcoming initial boat crewmember check rides. SERVANT also met Div 1 OPFAC SILVER CHARM near Yerba Buena Island to conduct towing training.
- Flotilla 12-91 will hold a Mini-OPTREX for recertification of two current coxswains and Initial Check Rides for a coxswain and two boat crew trainees for 10 FEB.
- A Division 12 Surface OPTREX is in the planning stages for September 8, 2024.
- As of 31 JAN, Division 12 members conducted 81.5 hours of surface operations missions under orders.
- As of 31 JAN, Division 12 has four (4) certified Coxswains, six (6) certified BCMs, one (1) Coxswain-in-training, and 4 (four) BCMs-in-training.
