- B. Be sure to enter your hours and number of VSCs accurately, splitting the 91A VSCs, and the 91H Paddlecraft VSCs.

4. REYR message from Pam Berger:

REYR processing is now being performed automatically, members who fail to meet the requirements to maintain currency in a competency will see their competencies set to REYR on the date the task is past due. For a competency to be set to Certified, the member must complete the task(s) that were missed, record the activity in AUXDATA and notify the DIRAUX Office, via the COLM, with a request to have the competency placed in Certified status.

According to policy, competencies that have had no activity in 5+ years have been set to Archive.
