Details:

- √ 2024 D11 (dpw) tasking assignments (52 Bridges & 830 PATONs) for District Aid Verifiers:
 - o Completed 123 PATON Verifications (15%) which are due September 30, 2024
 - Completed 40 Bridge Surveys (77%) which are due May 31, 2024
- ✓ District 113 has **31** certified AV-PQS Aid Verifiers and **14** Trainees
- ✓ Conducted two night PATON patrols aboard AudreyL on April 8 & 15.
- ✓ District 113 has **36** raster charts subject to cancellation. **21** have been cancelled thusfar, **15** pending cancellation July 31, 2024. The July cancellations will complete the elimination of all raster charts in our District. (see attached chart)
- ✓ An Aux C-06 C School was held in Yorktown, VA April 26-28, 2024- 21 Students attended and the class was well received.

Activities:

- ✓ April has seen over 3/4th of the bridge surveys completed to date setting the stage for an excellent completion rate by the due date. PATON verifications are well underway.
- ✓ Re-writes of National documents have been completed and distributed to All Auxiliary: Coast Guard Auxiliary Aids to Navigation Program and AV-PQS Standards handbook. Plans are being made to make the switch over to the new guidance.
- ✓ Co-taught C-06 School in Yorktown, VA during April 26-28.

Challenges:

✓ In recognition of retirement and loss of AV personnel, loss of facility support and restrictions on mode of travel to do verifications and surveys, it is understood that 100% completion is a stretch goal for 2024. Consequently, priorities have been established to complete surveys and verifications in the following order: Bridges, Class I, Class II and then Class III PATONs

Future Activities:

- ✓ Attending all D113 Board & Staff online & onsite meetings and all National NS program meetings.
- ✓ Update pending new PATON adds to District 113 10 new PATONs pending install.
- ✓ Schedule and conduct July patrols for Division 10

Agency Interactions:

✓ Direct interaction with D11-dpw and National NS staff.

2024 Goals and Objectives:

- ✓ **Completed for 2024:** Distribute all electronic and paper PATON verification sheets to SO-NSs in both 11N and 11S by mid/late-January 2024
- ✓ **Completed for 2024:** Distribute all electronic and paper Bridge survey sheets to SO-NSs in 11N by end of January 2024
- ✓ Complete 100% of District 11N bridge surveys by May 31, 2024 77% complete

- ✓ Complete 100% of District 11N PATON verifications by September 30, 2024 in Divisions with both facilities and more than one AV PQS personnel. 15% complete.
- ✓ Completed for 2024: Teach C-06 School in April 2024
- ✓ **Completed for 2023 Awards**: Calculate and nominate AV personnel for NS awards at the end of January 2024 for 2023 awards
- ✓ Improve the count of AV personnel in district 11N by converting at least two of the existing trainees to AV PQS.
